Executive Summary

A resolution stating Council intent to utilize American Rescue Plan Act (ARPA) funds and directing staff to negotiate agreements for Council consideration.

Discussion

The City of Columbia received \$25.2 million in American Rescue Plan Act (ARPA) funds to address the public health and economic impacts of the COVID-19 pandemic. The first half of the funding was designated for initiatives related to:

- Homelessness
- Community violence
- Behavioral crisis care mental health services
- Workforce development.

Council requested that the second half be allocated to priority areas identified by the community. A community-wide survey was conducted during the month of June 2022 to gather feedback. The survey data was accompanied by conversations collected via focus groups, which were conducted in the month of August, 2022. Council selected five priority areas for funding consideration for the second half of the funding:

- Access to Services
- Affordable Housing
- Mental Health Access
- Homelessness
- Workforce Development/Support

Between January and April of 2023 staff published a series of requests for proposals for the above priority areas. An internal review team evaluated the letters of intent based on the following criteria: ARPA priority, demonstration of need, efficiency, equity impact, outcome measurement, financial sustainability, and strategic plan alignment. Ninety-one letters of intent were submitted totaling \$95,962,178. Proposals were scored and those who scored above average were invited to submit a full proposal. Fifty-one (51) full proposals were submitted totaling \$31,593,304.86.

The full proposals were evaluated by a mayoral appointed and council approved ARPA committee. The committee reviewed the proposals. Recommendations and findings were presented to Council by the Committee Chair.

Council further reviewed the proposals along with the recommendations from the ARPA Committee. The following summarizes the funding recommendations by priority area:

- Access to Services \$1,325,000
- Affordable Housing \$8,600,000
- Community Violence \$2,170,000
- Homelessness \$5,665,000
- Mental Health \$3,000,000
- Workforce Development \$2,449,961
- Workforce Support \$1,324,663
- Capacity Building \$750,000

Exhibit A includes the organizations and proposals Council intends to fund.

If Exhibit A is approved, staff from Public Health and Human Services, Finance and Law Departments will coordinate with the organizations receiving funds to develop appropriate agreements for Council approval.

Fiscal Impact
