Re: Grant Renewal – FY2024 DWI Saturation Enforcement Grant

#### **Executive Summary**

Staff has prepared for Council consideration an ordinance authorizing acceptance of the DWI Saturation Enforcement Grant in the amount of \$11,000.00 from the Missouri Department of Transportation; and authorizing the City Manager to sign the contract.

#### Discussion

This grant provides funding for overtime and training for off duty officers to conduct special traffic enforcements identifying and apprehending DWI violations through saturation patrols. This grant runs in conjunction with the Full Time DWI Unit Grant. This contract period is October 1, 2023 through September 30, 2024.

#### Fiscal Impact

Short-Term Impact: The grant provides reimbursement for overtime pay and training; no matching funds are required. Both revenue and expense were included in the FY24 budget. Long-Term Impact: 12 month grant, no anticipated costs beyond years two.
