Re: Authorizing the installation of street lights at 419 Parkade Avenue, on the cul-de-sac of Dartmouth off of College Park Drive, at the intersection of West Green Meadows Road and Eastham Drive, and along Hanover Boulevard in association with a planned traffic calming project.

Executive Summary

Staff has prepared for Council consideration a resolution recommending the installation of additional streetlights. The Street Lighting Committee, which is comprised of staff from the Utilities and Public Works Departments, Office of Neighborhood Services, Police, and Office of Sustainability, met for their quarterly meeting on September 11, 2023 to discuss eight (8) individual requests for additional streetlights. After reviewing these requests, the committee is recommending approval of four (4) of these requests for additional street lighting.

Discussion

The Street Lighting Committee, received eight requests for additional streetlights. After evaluation, the staff of the Street Lighting Committee recommends four street lighting additions.

A request for additional lighting near 419 Parkade Boulevard was reviewed. It has been determined the pole at this location was recently replaced and the existing streetlight was not reinstalled. The streetlight committee recommends the replacement of the previously existing light with a 1-square LED as shown in Exhibit 1 of the Project Graphics. The estimated cost to install this light is \$800 and will be funded from the annual Capital Improvement Project (CIP) E0052 for Annual Street Light Additions for which funds have already been appropriated.

A request for additional lighting on the cul-de-sac of Dartmouth off of College Park Drive was reviewed. It has been determined that the lighting Dartmouth is not in accordance with Chapter 27-149 of the City's code of Ordinances in regards to street lighting along residential streets. The streetlight committee recommends the installation of 1 additional streetlight on the cul-de-sac of Dartmouth as shown in Exhibit 2 of the Project Graphics. The streetlight is proposed to be a decorative LED post top luminaire mounted on a black standard. The estimated cost to install this light is \$2,800 and will be constructed as part of the annual Capital Improvement Project (CIP) E0052 for Annual Street Light Additions for which funds have already been appropriated.

A request for additional lighting at the intersection of W. Green Meadows Road was reviewed. It has been determined that a barrier island installed on Eastham Drive at the intersection of W. Green Meadows Road is not adequately lit in and requires additional area

lighting. The streetlight committee recommends the installation of 1 additional streetlight at the intersection of W. Green Meadows Road and Eastham Drive as shown in Exhibit 3 of the Project Graphics. The streetlight is proposed to be a 1-square LED mast arm mounted luminaire. The estimated cost to install this light is \$1,800 and will be constructed as part of the annual Capital Improvement Project (CIP) E0052 for Annual Street Light Additions for which funds have already been appropriated.

A request for additional lighting along Hanover Boulevard in association with a proposed traffic calming project was reviewed. It has been determined the previously designed lighting on Hanover Boulevard was not completed due to the lack of existing power source and that several streetlights were non-functional. The existing streetlights that were non-functional have been subsequently repaired. The streetlight committee recommends the addition of one mast arm mounted 4-square LED and one decorative LED post top luminaire be added along Hanover Boulevard as shown in Exhibit 4 of the Project Graphics. The estimated cost to install this light is \$4,500 and will be funded from the annual Capital Improvement Project (CIP) E0052 for Annual Street Light Additions for which funds have already been appropriated.

All other requests were reviewed by the committee and deemed in accordance with Chapter 27-149 of the City's code of Ordinances in regards to street lighting along residential streets.

Fiscal Impact
