Re: Authorizing Amendment 9 to the general cooperative agreement with the Boone County Regional Sewer District to remove the portion of the agreement related to the

Midway area sewer service

Executive Summary

Staff has prepared for Council consideration an ordinance authorizing the City Manager to execute Amendment 9 to the General Cooperative Agreement Dated March 8, 2011 with the Boone County Regional Sewer District. This amendment removes the portion of the Agreement relative to the "Midway Area Cooperative Agreement" and the associated financial participation in the construction of the "Henderson Branch Sewer Extension".

Discussion

On August 17, 2015 the City Council approved Amendment 3 to the general cooperative agreement with the Boone County Regional Sewer District relating to sewer service within the Midway area and financial participation in the construction of Henderson Branch Sewer Extension. City staff proceeded with the standard public improvement process for the Henderson Branch Sewer Extension. On May 21, 2018 and again on September 4, 2018, the City Council defeated the ordinance authorizing construction of the sanitary sewer to serve the Henderson Branch Watershed. On February 1, 2021, the City Council re-appropriated the funds from the Henderson Branch Sewer Extension Project to sewer rehabilitation projects.

Amendment 3 obligates Boone County Regional Sewer District to reimburse the City in an amount not to exceed \$628,047.00 for construction of the Henderson Branch Sewer Extension. Amendment 9 is necessary to remove the "Midway Area Cooperative Agreement", "BCRSD Midway Connection Agreement Map" and financial participation in the "Henderson Branch Sewer Extension" from the General Cooperative Agreement with the Boone County Regional Sewer District. This agreement will remove all requirements to construct a sewer extension in the Henderson Branch and assignments of sewer territory in the Midway area. This relieves the Boone County Regional Sewer District of unknown future financial liability with regard to a Henderson Branch Sewer Extension. Additionally, by approving Amendment 9, this allows future development in the Midway area without causing the Boone County Regional Sewer District or the City of Columbia to be in a situation where either party is failing to perform contractual obligations outlined in Amendment 3 and the General Cooperative Agreement. This would also allow for future discussions on the construction of this sewer without the existing financial obligations and territorial boundaries.
