We explained how the choice of culvert (open bottom) and the lowering of the channel upstream of the culvert was done, in part, to help limit the velocity of stormwater as it leaves the ne culvert. Mr. Gibb suggested aligning the new culvert a little better with the downstream channel and strengthening the erosion control on the east side of the stream to counter the tendency of the water to dig into that part of the streambank. We agreed to look at that, keeping in mind that we are trying to preserve a large sycamore on the other side of the stream.
