Re: Authorizing the installation of street lights at the intersections of Rice Road and McKee

Street, on Waco Road from Brown Station Road to Arbor Pointe Parkway, and at the

intersection of Bethel Road and Old Plank Road.

#### **Executive Summary**

Staff has prepared for Council consideration a resolution recommending the installation of additional streetlights. The Street Lighting Committee, which is comprised of staff from the Utilities and Public Works Departments, Office of Neighborhood Services, Police, and Office of Sustainability, met for their quarterly meeting on March 11, 2024 to discuss nine (9) individual requests for additional streetlights. After reviewing these requests, the committee is recommending approval of three (3) of these requests for additional street lighting.

#### Discussion

The Street Lighting Committee, received nine requests for additional streetlights. After evaluation, the staff of the Street Lighting Committee recommends three (3) street lighting additions.

A request for additional lighting at the intersection of Rice Road and McKee Street was reviewed. It has been determined the pole at this location was recently replaced and the existing streetlight was not reinstalled. The streetlight committee recommends the replacement of the previously existing light with a 4-square LED as shown in Exhibit 1 of the Project Graphics. The estimated cost to install this light is \$1,800 and will be funded from the annual Capital Improvement Project (CIP) E0052 for Annual Street Light Additions for which funds have already been appropriated.

A request for additional lighting on Waco Road west of Brown Station Road to Arbor Pointe Parkway was reviewed. Waco Road is identified as a minor arterial street on the current CATSO Major Roadway Plan and is currently has no street lighting installed as required by section 27-150 of the Code of Ordinances. The Lighting Committee recommends that this work be brought forward as a future public improvement for the design and construction of street lighting on this portion of Waco Road shown in Exhibit 2 of the Project Graphics. There has been no cost estimate prepared for this work at this time.

A request for lighting at the intersection of Bethel Road and Old Plank Road was reviewed. After review, it has been determined that this intersection is inadequately lit and that additional street lighting is warranted. The streetlight committee recommends that a 400-watt equivalent LED mast mounted street light be added at this intersection as shown in Exhibit 3 of the Project Graphics. This intersection is in Boone Electric's service territory so the

improvement will be funded by Boone Electric and charged back to the city at a monthly rate of \$16.50 per light.

#### Fiscal Impact

Short-Term Impact: The cost of the proposed streetlights is \$1,800 to be charged to Capital Project E0052 for street light additions.

Long-Term Impact: Charges for lights installed in the Boone Electric service area will be approximately \$200 annually.
