## Executive Summary

An ordinance authorizing the City Manager to sign the HIV Case Management Contract Amendment #01 between the City of Columbia and the Missouri Department of Health and Human Services for the period of April 1, 2024 through March 31, 2025.

## Discussion

The Missouri Department of Health and Senior Services contracts with Local Public Health Departments to provide HIV Case Management services for Missouri residents living with human immunodeficiency virus (HIV) and/or acquired immunodeficiency syndrome (AIDS). This contract provides funding for Public Health and Human Services (PHHS) to deliver HIV case management in the 37 county Central Region. This is a one-year renewal of the existing contract. The contract renewal period is April 2, 2024- March 31, 2025 with a flat funding amount of \$1,092,726.
