Grant)

#### Executive Summary

Staff has prepared for Council consideration an ordinance authorizing acceptance of the 2024-2025 STOP VAWA grant in the amount of \$195,255.10 from the Missouri Department of Public Safety and authorizing the City Manager and Chief of Police to sign the contract. This is a renewal of an existing grant that will continue to fund a portion of existing personnel's (two sworn and one non-sworn) salaries/benefits that are assigned to investigate domestic violence cases.

#### Discussion

This grant renewal will continue funding a portion of the two DOVE (Domestic Violence) Unit officer's salaries/benefits and provides 51% funding for a temporary part-time employee from 1/1/24-9/30/24 at which time it funds a full time non-sworn (Admin Tech I) position w/ benefits at 51%.

The contract period is January 1, 2024 through December 31, 2025.

#### Fiscal Impact

Short-Term Impact: No fiscal impact for FY2024 as both revenue and expense were included in the budget. For FY2025 – there is a net increase to the Personnel budget of \$13,307.00 to make the current PT DOVE Assistant a Full Time Admin Tech I position, this proposed change has been included in FY2025 position requests portion of the preliminary budget document submitted by the Police Dept.

Long-Term Impact: No anticipated cost beyond year two.
