Area

Executive Summary

Staff has prepared for Council consideration, an ordinance authorizing the City Manager to execute a Joint Funding Agreement with the United States Geological Survey (USGS) for groundwater monitoring in the McBaine Bottoms, around the City's wetland treatment units, and on the Eagle Bluffs Conservation property, for a one year period. These wells will be monitored for constituents of interest to the City including, inorganic ions, pesticides, wastewater organics and pharmaceutical compounds. The cost for this project is shared between the Sewer Division and the Water Division of Columbia Utilities Department and funds have been appropriated in the operating budgets.

Discussion

In 1992 a collaborative agreement among the USGS, the City of Columbia and the Missouri Department of Conservation began groundwater monitoring in the McBaine Bottoms around the City's wetland treatment units and on the Eagle Bluffs Conservation property. The purpose of the study was to assess the effect of the constructed wetlands on the ground water quality and flow. This initial study was completed in 1999 and a significant conclusion was that compounds associated with sewage effluent in the wetlands could potentially migrate from the wetlands toward the City's municipal drinking water supply well field. Based on the results, the parties involved concurred that the water quality monitoring should continue and that all analysis should be performed by the USGS laboratory for consistency. The purpose of performing these studies is to provide the City with the information needed to protect the well field and ensure good quality drinking water for the City.

In 2015, the USGS provided the City a proposal to continue the monitoring for an additional six years, renewable annually, which includes detailed information on the purpose and objective of the study, the wells to be monitored, analysis to be performed and the annual cost for each of the six years. The proposal is attached and includes detailed information on the purpose and objective of the study. This agreement is for year two of the six years included in the proposal.

Fiscal Impact

Short-Term Impact: The cost to the City for year two (FY16) of the proposal is \$57,160.00 with the Sewer Division paying 80% or \$45,728.00 and the Water Division paying 20% or \$11,432.00. The funding has been included in the operating budgets for each division and will require no special appropriations.

Long-Term Impact: The future costs for years three through six (FY17 - FY20) \$62,850.00, \$64,200.00, \$69,000.00 and \$67,750.00 respectively, totaling \$263,800.00. The annual amounts will be appropriated each year with the annual budget.
