Re: Installation of streetlights on Elderbrook, West Broadway and East Campus

Executive Summary

The staff Street Lighting Committee has received three requests for streetlights inside of Water and Light's service territory.

- 1) Installation of 1 post top luminaire near the end of Elderbrook Dr.
- 2) Installation of 1streetlight at the entrance to Off Broadway Condos along West Broadway.
- 3) Improving lighting levels throughout the East Campus neighborhood.

The staff Street Lighting Committee has reviewed these requests and recommends the following:

- 1) Approving the request for installation of 1 post top luminaire near the end of Elderbrook Dr.
- 2) Dis-approving the request for installation of 1streetlight at the entrance to Off Broadway Condos along West Broadway.
- 3) Directing staff to commission a study with a lighting consultant to evaluate the lighting levels throughout the East Campus neighborhood to determine scope and costs of an appropriate lighting project.

Discussion

A request for installing a single post top luminaire near the end of Elderbrook Dr. has been received from the residents of the neighborhood. Staff from the Office of Neighborhood Services has reached out reached out to the 2 property owners most affected and both were in support. Letters were sent to the other two property owners but did not get a response. This area is along the east side of the Elderbrook Dr. dead end. The Street Lighting Committee has reviewed this request and recommends installing a single post top luminaire as requested. The requested street light is located in the 3rd Ward.

The lighting fixture is a 38 watt LED decorative post top luminaires mounted on a black standard (Exhibit A) to match the existing style of lighting within the subdivision at the location shown in Exhibit B. Material and installation is estimated to be \$1,500 and will be charged to capital project EL0052 Annual Street Light Additions.

A request for installing a single streetlight at the entrance to Off Broadway Condos along West Broadway has been received from the management company of Off Broadway Condos. The staff Street Lighting Committee has reviewed this request and recommends disapproving the request. The entrance to Off Broadway Condos along West Broadway is on State Road TT (maintained by MoDOT) and the private drive into the Off Broadway Condos

complex. Neither of these roads is within the City's responsibility to maintain. The staff Street Lighting Committee would recommend Off Broadway Condos to install and maintain a dusk to dawn light at their entrance if increased lighting is desired. This would be at their expense.

A request for improving lighting levels throughout the East Campus neighborhood has been received. Staff has reviewed this request and is seeking direction on how to proceed. Generally, the staff Street Lighting Committee reviews requests for the installation of new lights where lighting does not currently exist.

The East Campus neighborhood is in an older section of Water & Light's service territory and is served primarily from overhead electric service. There are over 115 existing streetlights within the East Campus neighborhood (Exhibit C). Theses streetlights are attached directly to the wood poles used for the overhead electric distribution system, are placed at intersections and roughly 200 feet apart. This is far more than the minimum that Section 27-149 of the City's Code of Ordinances would require.

Staff has met with several groups that live or own property within the East Campus neighborhood including several students, members of the East Campus Neighborhood Association and rental property owners. Consensus among these groups is divided on the issue.

Staff recommends issuing an RFP for a lighting consultant to evaluate the lighting levels throughout the East Campus neighborhood to determine scope and costs of an appropriate lighting project. Staff proposes to issue a request for proposal for these services and will return to Council for approval and an appropriation of funds for this project.
