## AN ORDINANCE

authorizing grant agreements with the Mid-Missouri Solid Waste Management District for the purchase of a commercial recycling roll-off truck, commercial food waste containers and commercial recycling containers; appropriating funds; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

The form and content of the agreement shall be substantially in the same form as set forth in "Exhibit B" attached hereto.

SECTION 3. The City Manager is hereby authorized to execute a grant agreement with the Mid-Missouri Solid Waste Management District for the purchase of commercial recycling containers. The form and content of the agreement shall be substantially in the same form as set forth in "Exhibit C" attached hereto.

SECTION 4. The sum of \$70,000.00 is hereby appropriated from the State Revenue Account No. 557-0000-462.10-00 GMMS16 and \$136,000.00 is hereby appropriated from the Solid Waste Utility Fund Account No. 557-0000-351.01-00 to the Mini Recycling Roll-off Truck Account No. 557-6576-880.65-25 GMMS16.

SECTION 5. The sum of \$5,000.00 is hereby appropriated from the State Revenue Account No. 557-0000-462.10-00 GMMS17 and \$1,666.00 is hereby appropriated from the Solid Waste Utility Fund Account No. 557-0000-351.01-00 to the Commercial Food Waste Roll Carts Account No. 557-6576-633.14-60 GMMS17.

SECTION 6. The sum of \$5,000.00 is hereby appropriated from the State Revenue Account No. 557-0000-462.10-00 GMMS18 and \$1,666.00 is hereby appropriated from the

Solid Waste Utility Fund Account No. 557-0000-351.01-00 to the Commercial Recycling Roll Carts Account No. 557-6576-633.14-60 GMMS18.
