Re: Amendment No. 3 to Professional Engineering Services Agreement with TranSystems

Corporation for the MKT to Parkade Bike Boulevard (GetAbout) Project

Executive Summary

Authorizing the City Manager to execute Amendment No. 3 to the professional engineering services agreement with TranSystems Corporation for the design of the MKT to Parkade Bike Boulevard (GetAbout) project. The proposed amendment extends the Plans, Specifications and Estimates (PS&E) approval date by MoDOT, as well as the overall period of service date.

Discussion

On September 2, 2014, Council authorized an agreement for professional engineering services with TranSystems Corporation for design of the MKT to Parkade Bike Boulevard project. MoDOT requires engineering services contracts to have a specific PS&E date for delivery of plans. This no-cost contract amendment extends the PS&E delivery date to December 1, 2016 due to additional time needed because of delays in acquiring property. The period of service date is also being extended to September 1, 2017 to enable Transystems to provide technical assistance during construction should the need arise.
