Re: Appropriate funds to pay for the Nov 3, 2015 Park Sales Tax Election

#### **Executive Summary**

Parks & Recreation staff has prepared an ordinance to appropriate \$120,906 to pay the City's portion of the November 3, 2015 election.

#### Discussion

The November 3, 2015 election included two propositions: Proposition 1: City of Columbia's extension of the Park Sales Tax and Proposition 1: Harrisburg R8 School District. The City's portion of the election is \$120,906 and will be paid from the Park Sales Tax fund balance.

Historically, the City Clerk's budget has paid for all elections, but due to a number of City ballot issues in 2015 and expected shortfall in General Fund sales tax, each department is being asked to pay for their respective election costs.

Following payment for the election, staff estimates that the Park Sales Tax Fund balance is expected to be approximately \$1,088,000 by the end of the fiscal year.
