Executive Summary

Staff has prepared for Council consideration an ordinance amending Chapter 22 of the City Code at it relates to rates charged by the sewer utility.

Discussion

Part of Chapter 22 of the City Code governs the charges paid by customers of the sewer utility. An overall five percent increase in sewer fees are proposed for the Fiscal Year 2017 budget year. Four percent of the increase is related to coverage of bond indebtedness and one percent is to address increased cost of operation and maintenance.

The following are each proposed section change with a brief discussion of the proposed change.

Sec. 22-262 (a)(1) – proposed change clarifies residential customer to match historic practice. This change has no impact on rates or current operation.

Sec. 22-263 (b)(1) - proposed change will

- 1. Increase the residential base fee from \$11.01 per month to \$11.56 per month.
- 2. Increase the non-residential base fee approximately (given rounding variation) five percent for each of eleven water meter sizes.
- 3. Increase the volume rate, for all customers, from \$2.27 per CCF to \$2.38 per CCF.

Sec. 22-263 (b)(2) – proposed change will

- 1. Increase the unit charge for BOD (biochemical oxygen demand) in dollars per pound from \$0.289 to \$0.303.
- 2. Increase the unit charge for suspended solids in dollars per pound from \$0.198 to \$0.208.

Sec. 22.-264 (b) – proposed increases in connection fees. The residential and 5/8 inch meter connection fee is proposed to increase from \$1,600 to \$2,000. This is the third year of a proposed four year connection fee increase that would bring the residential connection fee to a total of \$2,400 in year four. The connection fees for the other 10 meter sizes will be increased by an amount equivalent to the \$400 increase for the 5/8 meter multiplied by the ratio of the meter capacity to the capacity of a 5/8 inch meter.

Fiscal Impact

The connection fee revenue will increase by 25%, for each new connection, due to this proposed increase and by an additional 20% if the fourth increase is approved in the future.
