AN ORDINANCE

declaring it is in the public interest to proceed with replacement and upgrade of water mains along portions of Elaine Drive, Alan Circle, Kent Drive, Gregory Drive and Teresa Drive in the Gregory Heights Subdivision; approving the plans and specifications; determining that the work shall be done by City employees; providing for payment for the improvement; and fixing the time when this ordinance shall become effective.

WHEREAS, the City Council has adopted a resolution declaring the necessity for the proposed replacement and upgrade of water mains along portions of Elaine Drive, Alan Circle, Kent Drive, Gregory Drive and Teresa Drive in the Gregory Heights Subdivision and setting a public hearing on this project; and

WHEREAS, the notice of a public hearing on this proposed project was published in a daily newspaper of general circulation in the city; and

WHEREAS, the public hearing on the project has been held.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The Council finds and determines that the replacement and upgrade of 2-inch and 4-inch water mains with a 6- inch PVC water main along portions of Elaine Drive, Alan Circle, Kent Drive, Gregory Drive and Teresa Drive in the Gregory Heights Subdivision is necessary for the welfare and improvement of the City and that it is in the public interest that such improvement be made. Specific improvements include the following:

- Installation of 250 feet of water main and a fire hydrant on Elaine Drive.
- Replacement of 780 feet of water main and relocation of a fire hydrant on Alan Circle.
- Replacement of 530 feet of water main on Kent Drive.
- Replacement of 740 feet of water main and a fire hydrant on Gregory Drive.
- Replacement of 440 feet of water main on Teresa Drive.

SECTION 2. The plans and specifications for this improvement, as prepared by the Director of the Water and Light Department, are hereby approved.

SECTION 3. As deemed advisable by the City Manager, city employees shall be used to construct the improvements.

SECTION 4. Payment for this improvement shall be made from the Water and Electric Fund using funds appropriated in Capital Improvement Project No. WT0255, and such other funds as may be lawfully appropriated.

SECTION 5. This ordinance shall be in full force and effect from and after its passage.
