#### Executive Summary

Staff is requesting Council adopt a resolution transferring \$706,862.89 from the Stadium TDD project account back to the original funding source in order to finalize and close the capital improvement project account.

#### Discussion

On April 2, 2012 Council passed Ordinance 21279 appropriating \$8,200,000 from Ioan proceeds to be received from the Missouri Highways & Transportation Commission (MHTC) to the Stadium TDD project account. The construction project is complete and staff is requesting Council authorize the transfer of the remaining cash balance of \$706,862.89 from the Stadium TDD project account back to the original funding source from which it was appropriated from. This action will finalize and close the capital improvement project account.
