- 1. The Department of Health and Senior Services hereby exercises its option to renew the above referenced contract for the period of October 1, 2016 through September 30, 2017. The total funding available shall not exceed \$133,772.00.
- 2. Delete the Scope of Work, Attachments, Exhibit, and Terms and Conditions in their entirety and replace with revised Scope of Work, Attachments, Exhibit, and Terms and Conditions, which is attached hereto and is incorporated by reference as if fully set forth herein.

1. GENERAL

- 1.1 The contract amount shall not exceed \$133,772.00 for the period of October 1, 2016 through September 30, 2017.
- 1.2 The Department has determined this contract is subrecipient in nature as defined in 2 CFR § 200.330. To the extent that this contract involves the use, in whole or in part, of federal funds, the Contractor shall comply with the special conditions contained in Attachment B, which is attached hereto and is incorporated by reference as if fully set forth herein.
- 1.3 This project is/was supported by the Health Resources and Services Administration (HRSA) of the U.S. Department of Health and Human Services (HHS) under the grant number, title, and amount listed in the Contract Funding Source(s) enclosure provided with this contract and zero percentage is/was financed with nongovernmental sources. This information or content and conclusions are those of the author and should not be construed as the official position or policy of, nor should any endorsements be inferred by HRSA, HHS or the U.S. Government.
- 1.4 The Contractor must be in compliance with the laws regarding conducting business in the State of Missouri. The Contractor shall provide documentation of compliance upon request by the Department. The compliance to conduct business in the state shall include, but not necessarily be limited to:

2. PURPOSE

- 2.1 The Healthy Families America (HFA) model, developed in 1992 by Prevent Child Abuse America, is based upon 12 Critical Elements. These Critical Elements are derived from more than 30 years of research to ensure programs are effective in working with families and are operationalized through a series of Best Practice Standards. This provides a solid structure for quality, yet offers programs the flexibility to design services specifically to meet the unique needs of families and communities. Model fidelity is illustrated through a comprehensive accreditation process, accessible at: http://www.healthyfamiliesamerica.org/.
- 2.2 HFA has a strong research base, which includes randomized control trials and welldesigned quasi-experimental research. To date, research and evaluation indicates impressive outcomes. Reviews of more than 15 evaluation studies of HFA programs in 12 states produced the following outcomes:
 - a. Reduced child maltreatment;
 - b. Increased utilizations of prenatal care and decreased pre-term, low weight babies;
 - c. Improved parent-child interaction and school readiness;
 - d. Decreased dependency on welfare, or TANF (Temporary Assistance to Needy Families) and other social services;
 - e. Increased access to primary care medical services; and
 - f. Increased immunization rates.
- 2.3 HFA program goals are to:
 - a. Build and sustain community partnerships to systematically engage overburdened families in home visiting services;
 - b. Cultivate and strengthen nurturing parent child relationships;
 - c. Promote healthy childhood growth and development; and
 - d. Enhance family functioning by reducing risk and building protective factors.
- 2.4 The HFA program focuses on low-income-based (185% of the poverty level or below), first time pregnant women (primiparous), women pregnant with subsequent pregnancies (mulitiparous) or primary caregivers and their index child(ren) until the minimum age of three (3) and maximum age of five (5). The first home visit shall occur either prenatally or within the first three months after birth.

3. DELIVERABLES AND OUTCOMES

3.1 The Contractor shall provide HFA model home visiting services in Boone County serving a minimum of forty three (43) primary caregivers and the index child(ren) (the

primary caregivers and the index child(ren) shall hereinafter be referred to as "clients") with a maximum of forty nine (49) clients.

- 3.2 The Contractor shall furnish all material, labor, facilities, equipment and supplies necessary to perform the services required unless otherwise stated herein.
- 3.3 Performance Requirements.
- 3.3.1 Identification of Clients the Contractor shall recruit clients through community resources and collaborative team relationships.
 - a. The Contractor's clients must be low-income pregnant women, postpartum women or primary caregivers of the index child(ren) (defined at 185% of the poverty level or Medicaid eligible) who are at risk of poor birth outcomes or child abuse and neglect due to socioeconomic status, education, previous experience as an abused child or adult, or other factors.
 - b. The Contractor shall assure that the participation of each eligible individual/family in the program is voluntary.
- 3.3.2 The Contractor shall administer assessment tools as recommended by HFA and the Department to all clients as indicated by the Model and recommendations made by the Department. Scores shall be entered into the Department supported data management system as indicated by the Department.
- 3.3.3 The Contractor shall make best efforts to implement the Program with fidelity to the HFA Model and shall adhere to all revisions made by HFA National Office in regard to HFA Best Practice Standards.
- 3.3.4 The Contractor shall develop or utilize an already established collaborative team within the community who the Contractor shall work with to promote the well-being of the participating clients. The team may consist of public health nurses; social workers; nutritionists; women, infants, and children program (WIC) staff; family support workers (FSW) and membership covering all other necessary disciplines dependent on the client's need.
- 3.4 Personnel and Staffing Requirements.
- 3.4.1 The Contractor shall develop job descriptions following HFA's sample job descriptions included in the HFA Site Development Guide available to HFA affiliated sites.
- 3.4.2 The Contractor shall develop a performance appraisal system for managing and monitoring home visitor performance. The specific standards for conduct during home visits with the clients must be integrated into the job descriptions and the performance appraisal system.

- 3.4.3 The Contractor shall ensure appropriate staffing ratios, scheduling flexibility and staff supervision patterns based upon the recommendations of the HFA model during any given period. HFA staffing recommendations are included in the HFA Site Development Guide available to HFA affiliated sites.
- 3.4.4 The Contractor shall ensure that the home visitors reflect the ethnic, cultural, and social characteristics of the community and that all home visitors are in good physical and emotional health with no physical or mental conditions that would interfere with the home visitor's home visiting responsibilities.
- 3.4.5 The Contractor shall obtain a medical report signed by a licensed physician or nurse practitioner that is under the supervision of a licensed physician, for each home visitor who will provide services pursuant to the requirements herein stating the home visitor is physically able to fulfill the requirements of this position and is free of communicable disease.
- 3.4.6 The Contractor shall only utilize staff that has direct interaction with pregnant women, postpartum women, primary caregivers, children, and/or families, whose medical examination reports include a "Risk Assessment for Tuberculosis" form completed and signed by a health care professional. The "Risk Assessment for Tuberculosis" form can be found at <u>http://health.mo.gov/safety/childcare/pdf/tbriskassessmentform.pdf</u>. If the person has signs or symptoms of tuberculosis, or risk factors for tuberculosis, then testing for tuberculosis shall occur.
 - a. If the person has no documented history of ever receiving a tuberculin skin test (TST), and elects to receive a TST, then a two (2) step TST is required (one actual skin test). A history of Bacilli Calmette-Guerin vaccination (BCG) shall not exempt a person from receiving a tuberculin test.
 - b. Persons that have a newly positive tuberculin test(s) shall not be allowed to work until a medical evaluation is performed to determine if the person has active contagious tuberculosis.
 - c. Persons with active contagious tuberculosis shall be excluded from employment until deemed non-infectious by the Department or the local public health agency. The person may return to work, as long as the person adheres to his/her prescribed treatment regimen.
 - d. The contractor shall report all positive tuberculin tests to the Department or local public health agency as required by 19 CSR 20-20.020.
 - e. Medical examination reports shall be completed no more than twelve (12) months prior to beginning employment with the Contractor.

- f. Any Contractor employee who is identified as having contact with an active tuberculosis case, shall be evaluated for tuberculosis to determine if the person has active contagious tuberculosis, or be excluded from work.
- 3.4.7 The Contractor shall require all home visitors and supervisory staff to be up-to-date on immunizations, including an annual influenza vaccination and current Tdap as recommended by the Centers for Disease Control and Prevention Advisory Committee on Immunization Practices (CDC ACIP). Refer to: http://www.immunize.org/catg.d/p4030.pdf. This information shall be kept in the agency personnel files for auditing purposes. Documentation shall also be kept for personnel with medical or religious exemptions as approved by the Department.
- 3.4.8 The Contractor's personnel that will have direct interaction with pregnant women, postpartum women, primary caregivers, children and/or families shall become registered with and/or undergo child abuse/neglect and criminal background screenings prior to providing services, using the Family Care Safety Registry (FCSR). Refer to: www.health.mo.gov/safety/fcsr/about.php. This includes compliance as specified in RSMo 660.317.
- 3.4.9 In addition to the FCSR, upon hire, the Contractor's personnel providing services directly to families and children via the contract must undergo a criminal background check as specified in RSMo 210.025, by completing and submitting two (2) sets of fingerprints, one to the Missouri State Highway Patrol (MSHP) and one to the national Federal Bureau of Investigation (FBI). The Contractor must register their agency with the Missouri Volunteer and Employee Criminal History Service (MOVEHCS) by following the instructions posted at: https://www.mshp.dps.missouri.gov/MSHPWeb/PatrolDivisions/CRID/MoVECHSProgram.html. Once registered through MOVECHS, the Contractor will access the Missouri Automated Criminal History System (MACHS) at: https://www.machs.mshp.dps.mo.gov/MACHSFP/home.html and follow the instructions
 - posted there to obtain both a MSHP and a national FBI criminal record check by registering with the Fingerprint Portal.
 - a. The Contractor's personnel shall not provide services via this contract until the FCSR and MACHS results for the personnel providing services have been received and reviewed by the Contractor.
 - b. Any personnel who has pled guilty or nolo contendere to or been found guilty of one or more of the following identified in the MACHS results shall not provide services under the contract:
 - 1. Any felony for an offense against the person as defined by chapter 565, RSMo, or any other offense against the person involving the endangerment of a child as prescribed by law;

- 2. Any misdemeanor or felony for a sexual offense as defined by chapter 566, RSMo;
- 3. Any misdemeanor or felony for an offense against the family as defined in chapter 568, RSMo, with the exception of the sale of fireworks, as defined in section 320.110, RSMo, to a child under the age of eighteen;
- 4. Any misdemeanor or felony for pornography or related offense as defined by chapter 573, RSMo; or
- 5. Any similar crime in any federal, state, municipal or other court of similar jurisdiction of which the supervisor has knowledge or any offenses or reports.
- c. An applicant shall be given an opportunity by the Contractor to offer any extenuating or mitigating circumstances regarding the findings or violations against such applicant. Such extenuating and mitigating circumstances may be considered by the Contractor in its determination of whether to permit such applicant to serve clients under this contract.
- d. Results of the above stated, as well as information resulting in a determination by the Contractor to permit applicants with findings to serve clients under the contract, shall be kept in the agency personnel files for Department auditing purposes upon request.
- 3.5 The Contractor shall ensure each home visitor has completed all the mandatory core trainings prior to any home visits as prescribed by HFA in the HFA Best Practice Standards available to HFA affiliates.
- 3.5.1 The Contractor's home visitors and supervisors shall attend training as required by HFA and HFA training information can be accessed at: http://www.healthyfamiliesamerica.org/core-training/.
- 3.5.2 The Contractor's home visitors and supervisors shall attend training as prescribed and provided by the Department.
- 3.5.3 The Contractor shall maintain a record of all trainings that the home visitors receive and document these trainings.
- 3.5.4 The Contractor is responsible for all costs incurred pertaining to HFA required trainings for new staff. The Contractor shall have 180 days for new employees to complete all HFA required trainings.
- 3.6 Data System, Recordkeeping and Reporting Requirements.
- 3.6.1 Contractors are required to fully participate in the plan for initial and ongoing data collection set forth by the Department. This shall include, but not be limited to,

utilization of the designated web-based data management system and standardized assessment tools established by the Department.

- a) The Contractor shall establish a permanent record for each enrolled participant upon program admission within the data management system designated by the Department.
- b) The Contractor must enter completed forms on each client while enrolled in the program and the disposition of each client, including information documenting that each enrolled client qualifies for the program.
- c) The Contractor shall participate in training on data collection and utilization of the data management system designated by the Department.
- d) Program data must be collected on all performance and systems outcome measures included in the data collection forms within the data management system designated by the Department.
- e) Program data must be collected for all enrolled individuals/families who receive services funded through this contract agreement.
- f) The Department must collect individual level demographic and service utilization data on all participants being served through this funding to analyze and understand the progress that children and families are making. Individual level and service utilization data may include, but are not limited to the following:
 - 1. Family's participation rate in the home visiting program (e.g., number of sessions/number of possible sessions, durations of sessions, attrition rates);
 - 2. Demographic data for the participant child(ren), pregnant woman, expectant father, parent(s) or primary caregiver receiving home visiting services including child's gender, age of all family members (including date of birth for child), at each data collection point and racial and ethnic background of all participants in the family;
 - 3. Participant child's exposure to languages other than English; and
 - 4. Family socioeconomic indicators (e.g., family income, employment status).
- g) Contractors shall comply with the State's data and safety monitoring plan including privacy of data, administration procedures that do not place individuals at risk of harm and compliance with applicable confidentiality provisions. Contractors must ensure that all staff involved in the home visiting program will be provided relevant training on this topic annually.

- h) Contractors must comply with national and state evaluation participation as required by the grantor and Department.
- i) The Contractor shall notify the Department of staffing changes.
 - 1. The Contractor shall notify the Department within five (5) days of hire of any individual requiring access to electronic data systems to perform the functions of their position relating to provision of services within this contract.
 - 2. The Contractor shall notify the Department within five (5) days of the resignation, termination, or change in job duties of any employee who has access to the electronic data system who no longer requires access to the electronic data system to perform the functions of their position relating to providing services within this contract.
- 3.6.2 The Contractor shall maintain an individual paper record for each client participating in the home visiting program. This record must contain all signed consents for participation and screening tools as well as any other information the Contractor deems necessary.
- 3.6.3 The Contractor shall store and maintain all client paper records, including the files, in a safe and secure location.
 - a) The Contractor must maintain all such records for five (5) years after the completion of service for an adult and to age twenty-three (23) for a minor.
 - b) The Contractor shall maintain strict confidentiality of all patient and client information or records that the Contractor establishes as a result of contract activities. The contents of such records shall not be disclosed to anyone other than the state agency and the client without a release of information form signed by the client.
- 3.7 Other Requirements.
- 3.7.1 Customer (Client) Satisfaction Survey.
- 3.7.2 Annually, the Contractor shall administer a customer satisfaction survey to all clients enrolled in the program and must submit the completed surveys to the Department by January 15.
- 3.7.3 The Contractor shall utilize the survey form that will be provided to the Contractor by the Department each year.
- 3.7.4 The Contractor shall perform the survey according to the requirements of the Department in effect at the time of the survey.
- 3.7.5 The Contractor shall administer an annual employee satisfaction survey to assess the level of job satisfaction of each employee and shall have a process in place for addressing

and resolving (when possible) employee satisfaction issues which will ultimately encourage staff retention.

- 3.7.6 The Contractor shall ensure personnel participation with the Department in regularly scheduled consultations and discussions regarding implementation of the program model, collaborative efforts, and efficiency of the program.
- 3.7.7 The Contractor shall collaborate with other home visiting programs funded through the Maternal and Child Health Block Grant Healthy Families Missouri Home Visiting (HFMoHV) program and shall participate in monthly conference calls and periodic face-to-face meetings arranged by the Department as needed for training needs and continuous quality improvement (CQI).

4. **REPORTS**

4.1 The Contractor shall submit a Subrecipient Annual Financial Report (Attachment C, which is attached hereto and is incorporated by reference as if fully set forth herein). For a contract period of twelve months or less, the Contractor shall submit this report at the time the final invoice is due. For a contract period over twelve months, the Contractor shall submit this report annually and at the time the final invoice is due.

5. **BUDGET AND ALLOWABLE COSTS**

- 5.1 The Department will reimburse the Contractor for an amount not to exceed the total contract amount for only the allowable costs in the budget categories stated in Attachment D, which is attached hereto and incorporated by reference as if fully set forth herein.
- 5.2 The Department reserves the right to reallocate or reduce contract funds at any time during the contract period due to underutilization of contract funds or changes in the availability of program funds. The Department will provide the Contractor with thirty (30) days prior written notification of any reallocation.
- 5.3 If the Contractor identifies specific needs within the Scope of Work, the Contractor may rebudget up to 10% of the total budget between object class categories of the budget without obtaining prior written approval of the Department. Such rebudgeting by the Contractor shall not cause an increase in the indirect cost category. The Contractor and the Department must agree to a written contract amendment for an increase to the indirect cost category or any other rebudgeting.
- 5.4 Indirect costs

- 5.4.1 Indirect costs are those associated with the management and oversight of any organization's activities and are a result of all activities of the contractor. Indirect costs may include such things as utilities, rent, administrative salaries, financial staff salaries, and building maintenance.
- 5.4.2 The Contractor shall not bill the Department for indirect costs that exceed 8.70% of the modified total direct costs as defined in 2 CFR § 200.68.
 - a. Modified Total Direct Cost Method (MTDC) means all direct salaries and wages, applicable fringe benefits, materials and supplies, services, travel, and subawards and subcontracts up to the first \$25,000 of each subaward or subcontract (regardless of the period of performance of the subawards and subcontracts under the award). MTDC excludes equipment, capital expenditures, charges for patient care, rental costs, tuition remission, scholarships and fellowships, participant support costs, and the portion of each subaward and subcontract in excess of \$25,000. Other items may only be excluded when necessary to avoid a serious inequity in the distribution of indirect costs, and with the approval of the cognizant agency for indirect costs.
- 5.4.3 It is the Contractor's responsibility to correctly apply the indirect rate to the applicable direct costs claimed on each invoice.
- 5.5. The Contractor shall maintain records for salary and wages charged under the contract that accurately reflect the work performed.
- 5.6 The Contractor must have the prior written approval of the Department for any travel related expenses.
- 5.7 The Contractor shall follow competitive procurement practices.

6. INVOICING AND PAYMENT

- 6.1 If the Contractor has not already submitted a properly completed Vendor Input/Automated Clearing House Electronic Funds Transfer (ACH-EFT) Application, the Contractor shall complete and submit this Application. The Department will make payments electronically to the Contractor's bank account. The Department may delay payment until the Vendor Input/ACH-EFT Application is received from the Contractor and validated by the Department.
- 6.1.1 A copy of Vendor Input/ACH-EFT Application and completion instructions may be obtained from the Internet at: <u>https://www.vendorservices.mo.gov/vendorservices/Portal/Default.aspx</u>

- 6.1.2 The Contractor must fax the Vendor Input/ACH-EFT Application to: Office of Administration, Division of Accounting at 573-526-9813.
- 6.2 The Contractor shall invoice the Department on the Contractor's original descriptive business invoice form. The Contractor shall use uniquely identifiable invoice numbers to distinguish an invoice from a previously submitted invoice.
- 6.3 The Contractor shall submit invoices monthly. Invoices shall be due by the last day of the month following the month in which the Contractor provided services under the contract. The Contractor shall perform the services prior to invoicing the Department.
- 6.4 The Department will pay the Contractor monthly upon the receipt and approval of an invoice and report(s) prepared according to the terms of this contract.
- 6.5 The Contractor shall submit invoices to: Missouri Department of Health and Senior Services Division of Community and Public Health Section for Healthy Families and Youth Bureau of Genetics and Healthy Childhood Home Visiting Program P.O. Box 570 Jefferson City, MO 65102-0570
- 6.6 The Contractor shall submit the final invoice within thirty (30) calendar days after the contract ending date. The Department shall have no obligation to pay any invoice submitted after the due date.
- 6.7 If the Department denies a request by the Contractor for payment or reimbursement, the Department will provide the Contractor with written notice of the reason(s) for denial.
- 6.8 The Contractor agrees that any audit exception noted by governmental auditors shall not be paid by the Department and shall be the sole responsibility of the Contractor. However, the Contractor may contest any such exception and the Department will pay the Contractor all amounts which the Contractor may ultimately be held entitled to receive as a result of any such legal action.
- 6.9 Notwithstanding any other payment provision of this contract, if the Contractor fails to perform required work or services, fails to submit reports when due, or is indebted to the United States government, the Department may withhold payment or reject invoices under this contract.

- 6.10 If the Contractor is overpaid by the Department, the Contractor shall provide the Department (1) with a check payable as instructed by the Department or (2) deduct the overpayment from an invoice as requested by the Department.
- 6.10.1 For payment by check, the Contractor shall issue a check made payable to "DHSS-DA-Fee Receipts" and mail the check to:

- 6.11 If the Department used a federal grant to pay the Contractor, the Catalog of Federal Domestic Assistance (CFDA) number assigned to the grant and the dollar amount paid from the grant is available on the State of Missouri Vendor Services Portal under the Vendor Payment section at <u>https://www.vendorservices.mo.gov/vendorservices/Portal/Default.aspx</u>. - 6.12 Other than the payments and reimbursements specified above, no other payments or reimbursements shall be made to the Contractor.

7. **AMENDMENTS**

7.1 Any changes to this contract shall be made only through execution of a written amendment signed and approved by an authorized signatory of each party.

8. MONITORING

- 8.1 The Department reserves the right to monitor the Contractor during the contract period to ensure financial and contractual compliance.
- 8.2 If the Department deems a Contractor to be high-risk, the Department may impose special conditions or restrictions on the Contractor, including but not limited to the following: withholding authority to proceed to the next phase of the project until the Department receives evidence of acceptable performance within a given contract period; requiring additional, more detailed financial reports or other documentation; additional project monitoring; requiring the Contractor to obtain technical or management assistance; or establishing additional prior approvals from the Department. The Department may impose special conditions or restrictions at the time of the contract

award or at any time after the contract award. The Department will provide written notification to the Contractor prior to the effective date of the high-risk status.

9. **DOCUMENT RETENTION**

- 9.1 The Contractor shall retain all books, records, and other documents relevant to this contract for a period of three (3) years after final payment or the completion of an audit, whichever is later, or as otherwise designated by the federal funding agency and stated in the contract.
- 9.2 The Contractor shall allow authorized representatives of the Department, State, and Federal Government to inspect these records upon request.
- 9.3 If the Contractor is subject to any litigation, claim, negotiation, audit or other action involving the records before the expiration of the three (3) year period, the Contractor shall retain the records until completion of the action and resolution of all issues which arise from it, or until the end of the regular three (3) year period, whichever is later.
- 9.4 If the Department is subject to any litigation, claim, negotiation, audit or other action involving the records, the Department will notify the Contractor in writing to extend the Contractor's retention period.
- 9.5 The Department may recover any payment it has made to the Contractor if the Contractor fails to retain adequate documentation.

10. CONFIDENTIALITY

- 10.1 The Contractor shall safeguard Protected Personally Identifiable Information (PII) as defined in 2 CFR § 200.82. The Contractor agrees it will assume liability for all disclosures of Protected PII and breaches by the Contractor and/or the Contractor's subcontractors and employees.
- 10.2 The Contractor shall maintain strict confidentiality of all patient and client information or records supplied to it by the Department or that the Contractor creates as a result of contract activities. Unless disclosure is required by law, the Contractor shall not disclose the contents of such records to anyone other than the Department, the patient/client, or the patient's/client's parent or legal guardian. The Contractor agrees it will assume liability for all disclosures of confidential information and breaches by the Contractor agrees to comply

with all applicable confidentiality and information security laws, including but not limited to sections 192.067 and 192.667, RSMo.

11. LIABILITY

- 11.1 The Contractor shall understand and agree that the Department cannot save and hold harmless and/or indemnify the Contractor or employees against any liability incurred or arising as a result of any activity of the Contractor or any activity of the Contractor's employees related to the Contractor's performance under the contract.
- 11.2 The relationship of the Contractor to the Department shall be that of an independent contractor. The Contractor shall have no authority to represent itself as an agent of the Department. Nothing in this contract is intended to, nor shall be construed in any manner as creating or establishing an agency relationship or the relationship of employer/employee between the parties. Therefore, the Contractor shall assume all legal and financial responsibility for taxes, FICA, employee fringe benefits, workers compensation, employee insurance, minimum wage requirements, overtime, or any other applicable employee related obligation or expense, and shall assume all costs, attorney fees, losses, judgments, and legal or equitable imposed remedies associated with the matters outlined in this paragraph in regards to the Contractor's subcontractors, employees and agents. The Contractor shall have no authority to bind the Department for any obligation or expense not specifically stated in this contract. This provision is not intended to waive any claim of sovereign immunity to which a public entity would otherwise be entitled to under Missouri law.
- 11.3 The Contractor shall be responsible for all claims, actions, liability, and loss (including court costs and attorney's fees) for any and all injury or damage (including death) occurring as a result of the Contractor's performance or the performance of any subcontractor, involving any equipment used or service provided, under the terms and conditions of this contract or any subcontract, or any condition created thereby, or based upon any violation of any state or federal statute, ordinance, building code, or regulation by Contractor. However, the Contractor shall not be responsible for any injury or damage occurring as a result of any negligent act or omission committed by the Department, including its officers, employees, and assigns. This provision is not intended to waive any claim of sovereign immunity to which a public entity would otherwise be entitled to under Missouri law.

12. PUBLICATIONS, COPYRIGHTS, AND RIGHTS IN DATA AND REPORTS

- 12.1 If the Contractor issues any press releases mentioning contract activities, the Contractor shall reference in the release both the contract number and the Department. If the Contractor creates any publications, including audiovisual items, produced with contract funds, the Contractor shall give credit to both the contract and the Department in the publication. The Contractor shall obtain approval from the Department prior to the release of such press releases or publications.
- 12.2 In accordance with the "Steven's Amendment" in the Department of Labor, Health and Human Services, and Education and Related Agencies Appropriations Act, the Contractor shall not issue any statements, press release, request for proposals, bid solicitations, and other documents describing projects or programs funded in whole or in part with Federal money unless it clearly states the following:
- 12.2.1 The percentage of the total costs of the program or project which will be financed with Federal money; and
- 12.2.2 The percentage of the total costs of the program or project which will be financed by nongovernmental sources.
- 12.3 The Contractor shall include the below language when issuing statements, press releases, requests for proposals, bid solicitations, and other Health Resources and Services Administration (HRSA) supported publications and forums describing projects or programs funded in whole or in part with HRSA funding, including websites. Examples of HRSA-supported publications include, but are not limited to manuals, toolkits, resource guides, case studies and issues briefs.
- 12.3.1 This project is/was supported by the Health Resources and Services Administration (HRSA) of the U.S. Department of Health and Human Services (HHS) under grant number and title for grant amount (*specify grant number, title, subaward amount and percentage financed with nongovernmental sources*). This information or content and conclusions are those of the author and should not be construed as the official position or policy of, nor should any endorsements be inferred by HRSA, HHS or the U.S. Government.
- 12.4 If the Contractor develops any copyrighted material as a result of this contract, the Department shall have a royalty-free, nonexclusive and irrevocable right to publish or use, and to authorize others to use, the work for Department purposes or the purpose of the State of Missouri.

13. AUTHORIZED PERSONNEL

- 13.1 The Contractor shall be responsible for assuring that all personnel are appropriately qualified and licensed or certified, as required by state, federal or local law, statute or regulation, respective to the services to be provided through this contract; and documentation of such licensure or certification shall be made available upon request.
- 13.2 The Contractor shall only utilize personnel authorized to work in the United States in accordance with applicable federal and state laws. This includes but is not limited to the Immigration Reform and Control Act of 1986 as codified at 8 U.S.C. § 1324a, the Illegal Immigration Reform and Immigrant Responsibility Act (IIRIRA) and Section 274A of the Immigration and Nationality Act. If the Contractor is found to be in violation of these requirements or the applicable laws of the state, federal and local laws and regulations, and if the State of Missouri has reasonable cause to believe that the contractor has knowingly employed individuals who are not eligible to work in the United States, the state shall have the right to cancel the contract immediately without penalty or recourse and suspend or debar the contractor from doing business with the state. The state may also withhold up to twenty-five percent of the total amount due to the Contractor. The Contractor agrees to fully cooperate with any audit or investigation from federal, state or local law enforcement agencies.
- 13.3 Affidavit of Work Authorization and Documentation: Pursuant to section 285.530, RSMo, if the Contractor meets the section 285.525, RSMo definition of a "business entity" ((<u>http://www.moga.mo.gov/mostatutes/stathtml/28500005301.html?&me=285.530</u>), the Contractor must affirm the Contractor's enrollment and participation in the E-Verify federal work authorization program with respect to the employees hired after enrollment in the program who are proposed to work in connection with the services requested herein. The Contractor should complete applicable portions of Exhibit 1, Business Entity Certification, Enrollment Documentation, and Affidavit of Work Authorization as attached hereto and incorporated by reference as if fully set forth herein. The applicable portions of Exhibit 1 must be submitted prior to an award of a contract.
- 13.4 If the Contractor meets the definition of a business entity as defined in section 285.525, RSMo pertaining to section 285.530, RSMo the Contractor shall maintain enrollment and participation in the E-Verify federal work authorization program with respect to the employees hired after enrollment in the program who are proposed to work in connection with the contracted services included herein. If the Contractor's business status changes during the life of the contract to become a business entity as defined in section 285.525, RSMo pertaining to section 285.530, RSMo then the Contractor shall, prior to the performance of any services as a business entity under the contract:

- 13.4.1 Enroll and participate in the E-Verify federal work authorization program with respect to the employees hired after enrollment in the program who are proposed to work in connection with the services required herein; AND
- 13.4.2 Provide to the Missouri Department of Health and Senior Services the documentation required in the exhibit titled, Business Entity Certification, Enrollment Documentation, and Affidavit of Work Authorization affirming said company's/individual's enrollment and participation in the E-Verify federal work authorization program; AND
- 13.4.3 Submit to the Missouri Department of Health and Senior Services a completed, notarized Affidavit of Work Authorization provided in the exhibit titled, Business Entity Certification, Enrollment Documentation, and Affidavit of Work Authorization.
- 13.5 In accordance with subsection 2 of section 285.530 RSMo, the contractor should renew their Affidavit of Work Authorization annually. A valid Affidavit of Work Authorization is necessary to award any new contracts.

14. TERMINATION

- 14.1 The Department, in its sole discretion, may terminate the obligations of each party under this contract, in whole or in part, effective immediately upon providing written notification to the Contractor if:
- 14.1.1 State and/or federal funds are not appropriated, continued, or available at a sufficient level to fund this contract; or
- 14.1.2 A change in federal or state law relevant to this contract occurs; or
- 14.1.3 A material change of the parties to the contract occurs; or
- 14.1.4 By request of the Contractor.
- 14.2 Each party under this contract may terminate the contract, in whole or in part, at any time, for its convenience without penalty or recourse by providing the following written notice:
- 14.2.1 The Department will provide written notice to the Contractor at least thirty (30) calendar days prior to the effective date of such termination.

- 14.2.2 The Contractor shall provide written notice to the Department at least sixty (60) calendar days prior to the effective date of such termination.
- 14.3 In the event of termination, the Department may exercise the rights set forth in 2 CFR § 200.315(b) to reproduce, publish, or otherwise use copyrighted material prepared, furnished or completed by the Contractor pursuant to the terms of the contract, and may authorize others to do the same. The Department may also exercise the rights set forth in 2 CFR § 200.315(d) to obtain, reproduce, or otherwise use the data prepared, furnished, or produced by the Contractor pursuant to the terms of the contract, and may authorize others to do the same. The Contractor shall be entitled to receive compensation for services and/or supplies performed in accordance with the contract prior to the effective date of the termination and for all non-cancelable obligations incurred pursuant to the contract prior to the effective date of the termination.

1. GENERAL

1.1 To the extent that this contract involves the use, in whole or in part, federal funds, the signature of the Contractor's authorized representative on the contract signature page indicates compliance with the following Certifications and special provisions.

2. CONTRACTOR'S CERTIFICATION REGARDING SUSPENSION AND DEBARMENT

- 2.1 The Contractor certifies that neither it nor its principals are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in this contract by any Federal department or agency pursuant to 2 CFR Part 180.
- 2.2 The Contractor shall include these certification requirements regarding debarment, suspension, ineligibility, and voluntary exclusion in all lower tier covered transactions.
- 2.3 If the Contractor enters into a covered transaction with another person at the next lower tier, the Contractor must verify that the person with whom it intends to do business is not excluded or disqualified by:
- 2.3.1 Checking the System of Award Management (SAM) <u>https://www.sam.gov;</u> or
- 2.3.2 Collecting a certification from that person; or
- 2.3.3 Adding a clause or condition to the covered transaction with that person.

3. CONTRACTOR'S CERTIFICATION REGARDING LOBBYING

5. CONTRACTOR'S CERTIFICATION REGARDING ENVIRONMENTAL TOBACCO SMOKE

- 5.1 The Pro-Children Act of 1994, (Public Law 103-227, 20 U.S.C. §§ 6081-6084), requires that smoking not be permitted in any portion of any indoor facility owned or leased or contracted for by an entity and used routinely or regularly for the provision of health, day care, early childhood development services, education or library services to children under the age of 18, if the services are funded by Federal programs either directly or through State or local governments, by Federal grant, contract, loan, or loan guarantee. STATE OF MISSOURI DEPARMENT OF HEALTH AND SENIOR SERVICES

TERMS AND CONDITIONS

This contract expresses the complete agreement of the parties and performance shall be governed solely by the specifications and requirements contained herein. Any change must be accomplished by a formal signed amendment prior to the effective date of such change.

1. APPLICABLE LAWS AND REGULATIONS

- a. The contract shall be construed according to the laws of the State of Missouri (state). The contractor shall comply with all local, state, and federal laws and regulations related to the performance of the contract to the extent that the same may be applicable.
- b. To the extent that a provision of the contract is contrary to the Constitution or laws of the State of Missouri or of the United States, the provisions shall be void and unenforceable. However, the balance of the contract shall remain in force between the parties unless terminated by consent of both the contractor and the state.
- c. The contractor must be registered and maintain good standing with the Secretary of State of the State of Missouri and other regulatory agencies, as may be required by law or regulations.
- d. The contractor must timely file and pay all Missouri sales, withholding, corporate and any other required Missouri tax returns and taxes, including interest and additions to tax.
- e. The exclusive venue for any legal proceeding relating to or arising out of the contract shall be in the Circuit Court of Cole County, Missouri.
- f. The contractor shall only employ personnel authorized to work in the United States in accordance with applicable federal and state laws and Executive Order 07-13 for work performed in the United States.

2. INVOICING AND PAYMENT

- a. The State of Missouri does not pay state or federal taxes unless otherwise required under law or regulation. Prices shall include all packing, handling and shipping charges FOB destination, freight prepaid and allowed unless otherwise specified herein.
- b. The statewide financial management system has been designed to capture certain receipt and payment information. For each purchase order received, an invoice must be submitted that references the purchase order number and must be itemized in accordance with items listed on the purchase order. Failure to comply with this requirement may delay processing of invoices for payment.
- c. The contractor shall not transfer any interest in the contract, whether by assignment or otherwise, without the prior written consent of the state.
- d. Payment for all equipment, supplies, and/or services required herein shall be made in arrears unless otherwise indicated in the specific contract terms.
- e. The State of Missouri assumes no obligation for equipment, supplies, and/or services shipped or provided in excess of the quantity ordered. Any unauthorized quantity is subject to the state's rejection and shall be returned at the contractor's expense.
- f. All invoices for equipment, supplies, and/or services purchased by the State of Missouri shall be subject to late payment charges as provided in section 34.055, RSMo.
- g. The State of Missouri reserves the right to purchase goods and services using the state purchasing card.

3. DELIVERY

Time is of the essence. Deliveries of equipment, supplies, and/or services must be made no later than the time stated in the contract or within a reasonable period of time, if a specific time is not stated.

4. INSPECTION AND ACCEPTANCE

- a. No equipment, supplies, and/or services received by an agency of the state pursuant to a contract shall be deemed accepted until the agency has had reasonable opportunity to inspect said equipment, supplies, and/or services.
- b. All equipment, supplies, and/or services which do not comply with the specifications and/or requirements or which are otherwise unacceptable or defective may be rejected. In addition, all equipment, supplies, and/or services which are discovered to be defective or which do not conform to any warranty of the contractor upon inspection (or at any later time if the defects contained were not reasonably ascertainable upon the initial inspection) may be rejected.
- c. The State of Missouri reserves the right to return any such rejected shipment at the contractor's expense for full credit or replacement and to specify a reasonable date by which replacements must be received.
- d. The State of Missouri's right to reject any unacceptable equipment, supplies, and/or services shall not exclude any other legal, equitable or contractual remedies the state may have.

5. CONFLICT OF INTEREST

Elected or appointed officials or employees of the State of Missouri or any political subdivision thereof, serving in an executive or administrative capacity, must comply with sections 105.452 and 105.454, RSMo, regarding conflict of interest.

6. WARRANTY

The contractor expressly warrants that all equipment, supplies, and/or services provided shall: (1) conform to each and every specification, drawing, sample or other description which was furnished to or adopted by the state, (2) be fit and sufficient for the purpose intended, (3) be merchantable, (4) be of good materials and workmanship, and (5) be free from defect. Such warranty shall survive delivery and shall not be deemed waived either by reason of the state's acceptance of or payment for said equipment, supplies, and/or services.

7. REMEDIES AND RIGHTS

- a. No provision in the contract shall be construed, expressly or implied, as a waiver by the State of Missouri of any existing or future right and/or remedy available by law in the event of any claim by the State of Missouri of the contractor's default or breach of contract.
- b. The contractor agrees and understands that the contract shall constitute an assignment by the contractor to the State of Missouri of all rights, title and interest in and to all causes of action that the contractor may have under the antitrust laws of the United States or the State of Missouri for which causes of action have accrued or will accrue as the result of or in relation to the particular equipment, supplies, and/or services purchased or procured by the contractor in the fulfillment of the contract with the State of Missouri.

8. CANCELLATION OF CONTRACT

- a. In the event of material breach of the contractual obligations by the contractor, the state may cancel the contract. At its sole discretion, the state may give the contractor an opportunity to cure the breach or to explain how the breach will be cured. The actual cure must be completed within no more than 10 working days from notification, or at a minimum the contractor must provide the state within 10 working days from notification a written plan detailing how the contractor intends to cure the breach.
- b. If the contractor fails to cure the breach or it circumstances demand immediate action, the state will issue a notice of cancellation terminating the contract immediately. If it is determined the state improperly cancelled the contract, such cancellation shall be deemed a termination for convenience in accordance with the contract.
- c. If the state cancels the contract for breach, the state reserves the right to obtain the equipment, supplies, and/or services to be provided pursuant to the contract from other sources and upon such terms and in such manner as the state deems appropriate and charge the contractor for any additional costs incurred thereby.
- d. The contractor understands and agrees that funds required to fund the contract must be appropriated by the General Assembly of the State of Missouri for each fiscal year included within the contract period. The contract shall not be binding upon the state for any period in which funds have not been appropriated, and the state shall not be liable for any costs associated with termination caused by lack of appropriations.

9. BANKRUPTCY OR INSOLVENCY

Upon filing for any bankruptcy or insolvency proceeding by or against the contractor, whether voluntary or involuntary, or upon the appointment of a receiver, trustee, or assignee for the benefit of creditors, the contractor must notify the state immediately. Upon learning of any such actions, the state reserves the right, at its sole discretion, to either cancel the contract or affirm the contract and hold the contractor responsible for damages.

10. INVENTIONS, PATENTS AND COPYRIGHTS

The contractor shall defend, protect, and hold harmless the State of Missouri, its officers, agents, and employees against all suits of law or in equity resulting from patent and copyright infringement concerning the contractor's performance or products produced under the terms of the contract.

11. NON-DISCRIMINATION AND AFFIRMATIVE ACTION

In connection with the furnishing of equipment, supplies, and/or services under the contract, the contractor and all subcontractors shall agree not to discriminate against recipients of services or employees or applicants for employment on the basis of race, color, religion, national origin, sex, age, disability, or veteran status unless otherwise provided by law. If the contractor or subcontractor employs at least 50 persons, they shall have and maintain an affirmative action program which shall include:

- a. A written policy statement committing the organization to affirmative action and assigning management responsibilities and procedures for evaluation and dissemination;
- b. The identification of a person designated to handle affirmative action;
- c. The establishment of non-discriminatory selection standards, objective measures to analyze recruitment, an upward mobility system, a wage and salary structure, and standards applicable to layoff, recall, discharge, demotion, and discipline;
- d. The exclusion of discrimination from all collective bargaining agreements; and
- e. Performance of an internal audit of the reporting system to monitor execution and to provide for future planning.

If discrimination by a contractor is found to exist, the state shall take appropriate enforcement action which may include, but not necessarily be limited to, cancellation of the contract, suspension, or debarment by the state until corrective action by the contractor is made and ensured, and referral to the Attorney General's Office, whichever enforcement action may be deemed most appropriate.
