Re: Providence Road Improvement Project - Contract for the Sale of Real Estate

Executive Summary

Authorizing the City Manager to execute a Contract for Sale of Real Estate, and all other documents relating to the acquisition of a tract of land in fee simple to facilitate the construction of the Providence Road Improvement project from Stadium Boulevard to Stewart Road.

Discussion

Staff is requesting Council authorize the City Manager to execute a Contract for Sale of Real Estate, and all other documents relating to the acquisition of a vacant lot located at the southwest corner of Providence Road and Burnam Road. The easements needed from this tract were appraised at \$79,025.00, and the entire tract appraised at \$125,163.00. The sellers requested that the City acquire the tract in its entirety, rather than just acquiring the necessary easements needed for the project. By acquiring the lot in fee simple the City will retain control of the lot for any future infrastructure improvements that may be necessary.

The seller's appraisal specified a higher value than the City's appraisal, so the sellers may elect to declare a charitable contribution in an amount to be established by the sellers.

Fiscal Impact
