Re: Authorize a Professional Engineering Services Agreement with Burns & McDonnell Engineering Company for Construction Phase Services related to the Reconstruction and Extension of Runway 13-31 and Taxiway B at the Columbia Regional Airport

Executive Summary

Staff is requesting Council authorize the City Manager to execute a professional engineering services agreement with Burns & McDonnell Engineering Company for construction phase services related to the reconstruction and extension of Runway 13-31 and Taxiway B at the Columbia Regional Airport. The cost for this service is \$997,918.00 and is eligible for 90% reimbursement by the Federal Aviation Administration (FAA).

Discussion

The City of Columbia received a grant agreement from the FAA in the amount of \$12,233,216 for the reconstruction and extension of Runway 13-31 and Taxiway B, which includes replacing the current asphalt with concrete, lengthening and widening the runway to 5,500' x 100', installation of medium intensity runway lighting, directional signage and pavement centerline and runway markings. The FAA will reimburse the City 90% or \$11,009,894. The City's local match is 10% or \$1,223,322.

A public hearing for this project was held, and a bid call through the Purchasing division was authorized on June 20, 2016. As part of the reconstruction and extension of Runway 13-31 and Taxiway B, staff is requesting Council authorize the City Manager to execute a professional engineering services agreement with Burns & McDonnell Engineering Company to provide construction phase services for a not to exceed amount of \$997,918.00. The FAA will reimburse the City 90% of this amount.

Fiscal Impact

Short-Term Impact: The professional engineering services agreement is for a not to exceed amount of \$997,918.00. The FAA will reimburse the City 90% or \$898,126.00. Long-Term Impact: The total project cost is \$12,233,216. The FAA will reimburse the City 90% or \$11,009,894. The City's local match is \$1,223,322, and is funded by Transportation Sales Tax.
