Re: Appropriating Funds to Close the Chapel Hill Road Improvement Project

Executive Summary

Staff is requesting Council authorize an appropriation of funds in the amount of \$156,518.55 in order to close the Chapel Hill Road-Future capital improvement project account.

Discussion

In August of 2002, Ordinance 17410 was passed by Council granting a variance from the Subdivision Regulations regarding sidewalk construction along the south side of Chapel Hill Road, west of Scott Boulevard, adjacent to Stonecrest Plats 3 and 4. The variance was subject to the condition that the property owner(s) would pay the City the equivalent cost of construction of a conventional concrete sidewalk, with payment required prior to issuance of a certificate of occupancy. The sidewalks were budgeted and constructed as part of the Chapel Hill Road capital improvement project prior to the construction of Scott Boulevard Phase I improvement project. In order to close the Chapel Hill Road-Future project account, staff is requesting to appropriate the account balance of \$156,518.55 to the Scott Boulevard Phase III project account.
