Re: Streetlight requests for Benton Street, Sanford Street and Carol Drive

## **Executive Summary**

The staff Street Lighting Committee, which is comprised of staff from the City's Law Department, Water & Light, Public Works, Office of Nighbrhood Services, Police, and Office of Sustainability, has received three requests for streetlights inside of Water & Light's electric service territory.

- 1) Installation of 1streetlight on the south side of Benton Street near 119 Benton Street.
- 2) Installation of 1streetlight at the coner of Sanford Street and Conley Avenue.
- 3) Installation of additional streetlight(s) near 2010 Carol Drive.

The staff Street Lighting Committee has reviewed these requests and recommends the following:

- 1) Approval of the request for installation of 1 streetlight on the south side of Benton Street near 119 Benton Street.
- 2) Approval of the request for installation of 1 streetlight at the coner of Sanford Street and Conley Avenue.
- 3) Denial of the request for Installation of additional streetlight(s) near 2010 Carol Drive.

#### Discussion

A request for additional lighting along Benton Street has been received from a resident within the neighborhood along with a petition with 12 signatures (Exhibit A) supporting this request. After review, it has been determined that the neighborhood is currently lit consistent with Chapter 27-149 of the City's code of Ordinances in regards to street lighting along residential streets. The streetlight committee recommends that because of the support shown by the petition that an additional streetlight be installed on the south side of Benton Street near 119 Benton Street as shown in Exhibit B. The streetlight is proposed to be a 57 watt LED with full cutoff.

A request for additional lighting at the coner of Sanford Street and Conley Avenue has been received from the University. After review, it has been determined that the corner is not lit in accordance with with Chapter 27-149 of the City's code of Ordinances in regards to street lighting along residential streets. Chapter 27-149 requires lighting to be installed at each intersection along residential streets. The streetlight committee recommends that an additional streetlight be installed at the coner of Sanford Street and Conley Avenueas shown in Exhibit C. The streetlight is proposed to be a 200 watt LED with full cutoff on galvanized steel pole to match the existing streetlights in the area.

A request for additional lighting near 2010 Carol Drive has been received from a resident

within the neighborhood. After review, it has been determined that the neighborhood is currently lit consistent with Chapter 27-149 of the City's code of Ordinances in regards to street lighting along residential streets see exhibit D. The streetlight committee does not recommend the installation of additional lighting near 2010 Carol Drive.
