WHEREAS, the General Cooperative Agreement contemplated that said agreement may be amended from time to time by adding, deleting, and/or revising the Special Conditions and Exhibits as needed and as mutually agreed upon by the Board of Trustees of the District and the City Council of the City; and

WHEREAS, the following are the revisions to the GENERAL CONDITIONS and the SPECIAL CONDITIONS of the General Cooperative Agreement.

## REVISIONS TO THE GENERAL CONDITIONS

- 1. Section 1 is deleted in its entirety. In its place a new Section 1 is included, as follows:
  - 1. The scope of the this agreement is limited to those geographic areas within the "Boundary of Area Covered by Agreement" on the attached Exhibits 1 through 10, and Exhibit 13, and which are entitled "State Highway HH Cooperative Agreement", "Westwood Meadows Cooperative Agreement", "El Rey Heights Cooperative Agreement", "Cow Branch Watershed Cooperative Agreement", "Little Bonne Femme Pump Station Cooperative Agreement", "Jerry Morris Subdivision Cooperative Agreement", "Water's Edge, Lakewood Villas, Lakewood Estates, Lakeland Acres and Pin Oak Subdivisions Service Area", "Abilene Acres Connection Agreement", "BCRSD Midway Connection Agreement Map", "Happy Hollow Estates" and "Arrowhead Lake Estates University Estates".

All other GENERAL CONDITIONS of the original March 8th, 2011, General Cooperative Agreement shall remain in effect.

END OF GENERAL CONDITIONS, BEGINNING OF SPECIAL CONDITIONS

## SPECIAL CONDITIONS

- 1. Add the following Special Condition 12.
  - 12. The City and District agree that the customers in the District's service area shown on Exhibit 13, "Arrowhead Lake Estates University Estates" are and shall remain connected to the City's wastewater treatment and collection system as provided for in the GENERAL CONDITIONS of this agreement.
    - a. Within 90 days of the date on which this "Amendment" becomes effective, District shall pay the "special connection fee per residential unit or the equivalent" required by the City for sewer connection to City's "Cascades Pump Station". The amount of said payment shall be the product of the number of lots on any final plat of the

crosshatched area as shown on the attached Exhibit 13 times the then current "special connection fee" required by the City.

- b. In addition to the "special connection fee" described herein, within 90 days of the date on which this "Amendment" becomes effective, District shall pay City's "regular connection fee per residential unit or the equivalent" which is required for sewer connection to City's wastewater treatment and collection system. The amount of said payment shall be the product of the number of lots on any final plat of the crosshatched area as shown on the attached Exhibit 13 times the City's then current "regular connection fee".
- c. This "Amendment" shall allow for no more than the connection of 4 single family homes, or the equivalent (not to exceed) discharge of 4 single family homes.
