AN ORDINANCE

authorizing recreational trails program project agreements and a land and water conservation fund project agreement with the State of Missouri – Department of Natural Resources; appropriating funds; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Manager is hereby authorized to execute a recreational trails program project agreement with the State of Missouri – Department of Natural Resources for replacement of bridges #5 and #7 located on the MKT Trail. The form and content of the agreement shall be substantially in the same form as set forth in "Exhibit A" attached hereto.

SECTION 2. The City Manager is hereby authorized to execute a recreational trails program project agreement with the State of Missouri – Department of Natural Resources for development and installation of informational kiosks throughout the Columbia trail system and replacement of trailhead signage at the Forum Nature Area. The form and content of the agreement shall be substantially in the same form as set forth in "Exhibit B" attached hereto.

SECTION 3. The City Manager is hereby authorized to execute a land and water conservation fund project agreement with the State of Missouri – Department of Natural Resources for construction of an inclusive playground, skate park, basketball court, baseball field and walking paths at the Norma Sutherland Smith Park. The form and content of the agreement shall be substantially in the same form as set forth in "Exhibit C" attached hereto.

SECTION 4. The sum of \$150,000.00 is hereby appropriated from Account No. 44008850-462000-00674, State Grant Revenue to Account No. 44008850-604990-00674, MKT Bridge Replacements Project.

SECTION 5. The sum of \$150,000.00 is hereby appropriated from Account No. 44008850-462000-00559, State Grant Revenue to Account No. 44008850-604990-00559, Norma Sutherland Smith Park Dev Project.

SECTION 6. The sum of \$10,000.00 is hereby appropriated from Account No. 11005220-462000, State Grant Revenue to Account No. 11005220-501100, PR Planning.

SECTION 7. This ordinance shall be in full force and effect from and after its passage.
