## AN ORDINANCE

vacating an unused trail easement that was acquired as part of the Hominy Creek Trail Phase II project; directing the City Clerk to have a copy of this ordinance recorded; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council finds and determines that a certain unused trail easement that was acquired as part of the Hominy Creek Trail Phase II project, more particularly described as follows:
