Re: Amending Chapter 14 to Establish a No Truck Route on Prairie Lane and Prairieview Drive

## **Executive Summary**

Staff is proposing to amend Section 14-179 of the City Code to prohibit through truck traffic on Prairie Lane and Prairieview Drive.

#### Discussion

Staff has been contacted by a number of concerned residents about heavy trucks using Prairie Lane and Prairieview Drive to get to and from the quarry located on Creasy Springs Road, to a developing neighborhood on Blue Ridge Road. Prairie Lane and Prairieview Drive were constructed to a residential street standard and not intended for heavy truck use. In 2015, Prairie Lane was overlaid with new asphalt and the residents are concerned about the structural integrity of the roadway. If Council authorizes this proposed amendment to the City Code to prohibit through truck traffic on Prairie Lane and Prairieview Drive, staff expects that heavy trucks leaving the quarry would use I-70 or Brown School Road to get to Blue Ridge Road.

The CATSO 2040 Long Range street project plan does include connectivity of Blue Ridge Road to Creasy Springs Road; however, until that happens heavy trucks will continue to use Prairie Lane and Prairieview Drive in order to access Blue Ridge Road from Creasy Springs Road. Staff recommends prohibiting through heavy truck traffic on Prairie Lane and Prairieview Drive.

#### Fiscal Impact

Short-Term Impact: \$225 for signs and labor to be paid from Street Operations budget

Long-Term Impact: \$225 as replacement signs may be needed
