

**FIRST AMENDMENT TO
AGREEMENT FOR PHYSICIAN
SERVICES BETWEEN
THE CURATORS OF THE UNIVERSITY OF
MISSOURI AND
CITY OF COLUMBIA, MISSOURI**

This First Amendment to Agreement for Physician Services Between the Curators of the University of Missouri and the City of Columbia Missouri, originally executed with the Effective Date of March 22, 2016 (hereinafter "First Amendment") is entered into on the date of the last signatory noted below and is by and between the Curators of the University of Missouri on behalf of the School of Medicine Department of Family and Community Medicine (hereinafter "University") and the City of Columbia, Missouri, a municipal corporation (hereinafter "City"). City and University are each individually referred to herein as a "Party" and collectively as the "Parties."

WHEREAS, the University would like to change the renewal term from the current date of March 22, 2017 and amend it to August 31, 2017.

WHEREAS, City is willing to amend the timing of the renewal term to coincide with the City's budget year.

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated into this First Amendment by this reference, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to amend "Section 1. Term" as follows:

The "Initial Term" shall be extended from March 22, 2017 to August 31, 2017 and it is after the end of this extended "Initial Term" that the Agreement shall automatically be renewed for successive terms of one (1) year (each such term a "Renewal Term"), unless the Agreement is terminated pursuant to the provisions of this Agreement.

Except as expressly provided in this First Amendment, the terms of the original Agreement shall remain in full force and effect and defined capitalized terms within the original Agreement shall have the same meaning as in the First Amendment. The Parties hereby adopt, ratify, and confirm the original Agreement as it is amended by this First Amendment. This First Amendment shall be binding on, and inure to the benefit of, the Parties hereto and their successors and assigns.
