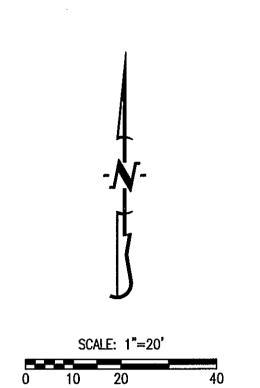
WALNUT ST

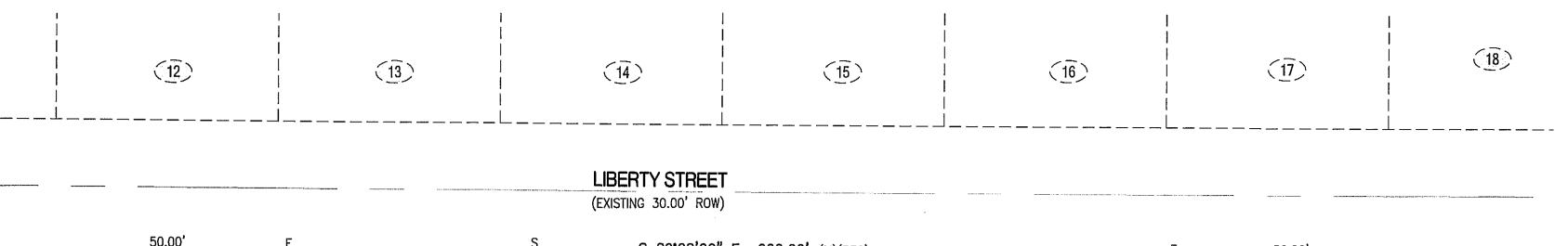

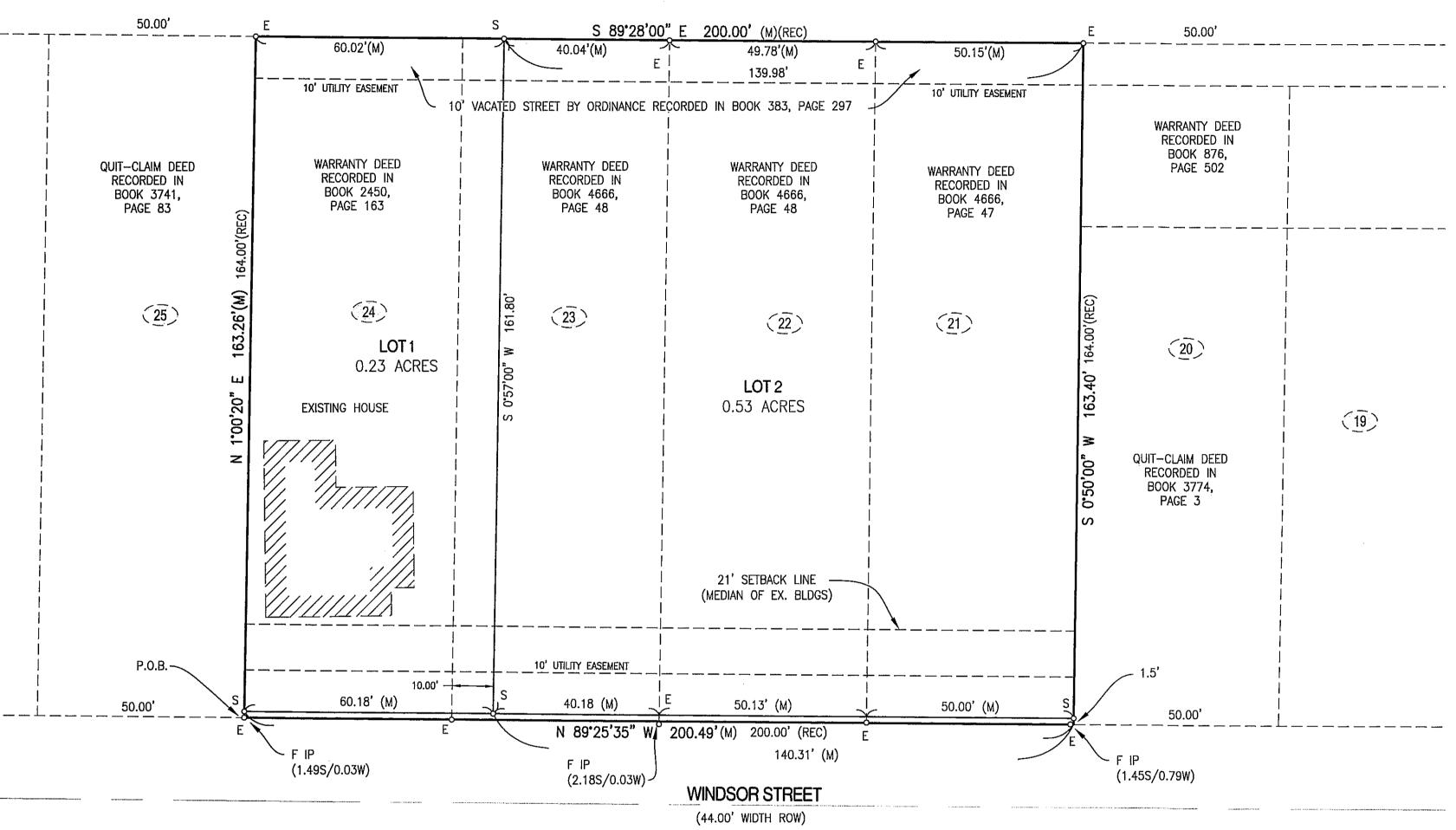
