

A SUBDIVISION OF A TRACT OF LAND IN THE WEST 1/2 OF THE NORTHWEST 1/4 OF SECTION 7, T48N, R12W, COLUMBIA, BOONE COUNTY, MISSOURI, DESCRIBED BY A WARRANTY DEED RECORDED IN BOOK 51, PAGE 263, EXCEPTING THEREFROM; A TRACT OF LAND DESCRIBED BY A WARRANTY DEED RECORDED IN BOOK 353, PAGE 448, A TRACT OF LAND DESCRIBED BY A QUIT CLAIM DEED RECORDED IN BOOK 523, PAGE 31, AND A TRACT OF LAND DESCRIBED BY A WARRANTY DEED RECORDED IN BOOK 381, PAGE 572 EXCEPT THAT PART OF LAST SAID TRACT, DESCRIBED BY A QUIT CLAIM DEED RECORDED IN BOOK 523, PAGE 33, ALL IN THE BOONE COUNTY, MISSOURI RECORDS.

BEGINNING AT THE NORTHWEST CORNER OF LOT 13 OF HARRISON'S SECOND ADDITION TO COLUMBIA, MISSOURI, SHOWN IN BOOK 35, PAGE 414; THENCE N 0°-16'E, ALONG THE EAST LINE OF PANNELL STREET, 51.0 FEET TO THE SOUTHWEST CORNER OF THE TRACT OF LAND DESCRIBED IN BOOK 353, PAGE 448; THENCE, FOLLOWING THE LINES OF SAID TRACT, N 89°-04'E 40.0 FEET; N 0°-16'E 99.0 FEET TO THE NORTHEAST CORNER OF SAID TRACT; THENCE, LEAVING THE LINES OF SAID TRACT, N 89°-04'E, ALONG THE SOUTH LINE OF WILKES BOULEVARD, 186.55 FEET TO THE NORTHEAST CORNER OF THE TRACT OF LAND DESCRIBED IN BOOK 523, PAGE 33; THENCE S 0°-20'-30"W, ALONG THE EAST LINE OF SAID TRACT AND THE WEST LINE OF THE TRACT OF LAND DESCRIBED IN BOOK 523, PAGE 31, 150.0 FEET TO THE SOUTHWEST CORNER OF LAST SAID TRACT, BEING ON THE NORTH LINE OF LOT 22 OF SAID ADDITION; THENCE S 89°-04'W, ALONG THE NORTH LINE OF SAID LOT 13 & 22, 246.35 FEET TO THE POINT OF BEGINNING AND CONTAINING 0.712 ACRE.


