Re: Columbia Public Schools Dark Fiber Lease.

Executive Summary

Staff has prepared for Council consideration an ordinance authorizing the City Manager to execute an Agreement with The Columbia School District for the lease of dark strands of the City's fiber optic system. The Columbia School District and City have previously entered into an agreement whereby the Columbia School District has used dark strands of the City's fiber optic system. The Columbia School District will pay the City \$3,847.00 per month for each dark fiber loop and \$250.00 monthly for each additional point-to-point service. The length of this agreement is five years.

Discussion

Staff has prepared for Council consideration an ordinance authorizing the City Manager to execute an Agreement with The Columbia School District for the lease of dark strands of the City's fiber optic system. The Columbia School District and City have previously entered into an agreement whereby the Columbia School District has used dark strands of the City's fiber optic loop. Earlier this year The Columbia School District solicited bids for dark fiber leases and other communications services. The City was the successful bidder for these services.

The City has constructed a single mode fiber optic cable system linking various City facilities and forming a complete fiber optic loop. The City has also previously installed and maintained radial fiber optic lines running from the fiber optic loop to various Columbia School District facilities.

The Columbia School District will pay the City \$3,847.00 per month for each dark fiber loop and \$250.00 monthly for each additional point-to-point service. The length of this agreement is five years.
