Executive Summary

Authorizing the City Manager to execute an Electric Distribution Line Relocation agreement with Boone Electric Cooperative, for a not to exceed amount of \$47,000, as part of the Discovery Drive Roadway and Sewer Extension project.

Discussion

The University of Missouri and the City of Columbia applied for and received an Economic Development Administration (EDA) grant related to the continued development of Discovery Research Park. This project includes construction of approximately 940 linear feet of new concrete roadway and 1,520 linear feet of 10-inch diameter gravity sanitary sewer. The total estimated project cost is \$1,227,810.

The project is funded from the EDA grant in the amount of \$613,905, the University's in-kind contribution of \$153,900 (donated land), the University's cash contribution of \$200,005, and the City' cash contribution of \$260,000. The City of Columbia is serving as the lead agency for the design contract administration, utility coordination, and construction inspection.

The project includes improvement to the intersection of Discovery Drive and Discovery Parkway by the addition of turn lanes, islands, sidewalk, etc. Boone Electric Cooperative has an existing electric distribution facility in a private easement at the intersection that is impacted by the improvements. Upon execution of this agreement, the City shall pay Boone Electric Cooperative the sum of \$47,000 for the relocation of their facilities.

Fiscal Impact
