Re: Bid Call for the Construction of Bioreactor Landfill Cell #6 and Appropriating Funds

Executive Summary

Staff has prepared for Council consideration an ordinance authorizing a call for bids through the Purchasing division for the construction of Bioreactor Landfill Cell #6 and appropriating funds for the construction. The Cell #6 project involves constructing an 11.26 acre bioreactor landfill area within the existing permitted airspace at the Columbia Landfill. This project is anticipated to cost \$5,500,000 and Special Obligation Bond funds need to be appropriated.

Discussion

This proposed Bioreactor Landfill Cell #6 project involves excavating approximately 200,000 cubic yards of soil, 190,000 cubic yards of rock, installing 11.26 acres of synthetic liner, installing 18,000 cubic yards of drainage media and constructing a new vehicle access road as shown on the attached diagram. There was a Public Hearing for this project on July 3, 2017 and Council directed staff to proceed with the project.

This project is being designed by Burns and McDonnell and the estimated construction cost for this project is \$5,500,000 and will be funded with Special Obligation Bonds. This ordinance will approve the bid call and appropriate \$5,424,043 of the proceeds from the bond sale to the Bioreactor Landfill Cell #6 project and \$83,957 of the proceeds to the Fiscal Agent Fees account.

Fiscal Impact

Short-Term Impact: The estimated construction cost for this project is \$5,500,000 and will be funded with Special Obligation Bond Funds.

Long-Term Impact: Costs will be included annually in the operations budget for the ongoing cost to operate and maintain the landfill.
