Runway 13-31 Rehabilitation Project at Columbia Regional Airport

Executive Summary

Authorizing a non-federal limited design and implementation reimbursable agreement with the Federal Aviation Administration related to the rehabilitation and extension of the Runway 13-31 project at Columbia Regional Airport.

Discussion

Staff is requesting Council authorize the City Manager to execute a non-federal limited design and implementation reimbursable agreement with the Department of Transportation Federal Aviation Administration (FAA) for the purpose relocating cables and a wind indicator related to the rehabilitation and extension of Runway 13-31 which is currently under construction at the Columbia Regional Airport. This relocation must be completed prior to the contractor completing the grading work in the Runway Visibility Zone (RVZ) for the line of sight requirement between the newly aligned runway and the primary runway.

The reimbursable agreement developed by the FAA, estimates the cost for the relocation not to exceed \$94,714.29 and is eligible for 90% reimbursement from the FAA.

Fiscal Impact

Short-Term Impact: \$94,714.29 will be paid from the Rehabilitation and Extension of Runway 13-31 and Taxiway B capital improvement project account, and is eligible for 90% reimbursement from the FAA.
