Executive Summary

Staff has prepared for Council consideration a Resolution authorizing the Fifth Amendment to the Software License and Services Agreement with Superion, LLC (formerly SunGard Public Sector, Inc) for Police Records Management System (RMS) software.

Discussion

This amendment is to purchase two additional training sessions for users of the Mobile Field Reporting system that is required for data entry into the Records System. Currently we have an estimate of 30 personnel that still require the training.

Fiscal Impact

Short-Term Impact: Fifth Amendment additional cost of \$8,960.00 which will be paid from remaining available budget in the Records Management System Capital Improvement Project (CIP#00498). This brings the total License & Software Agreement with Superion, LLC (formerly SunGard Public Sector, Inc.) to \$1,197,059.12 for the Records Management System (RMS) software.

Long-Term Impact: No additional costs beyond year one, as this is a one-time cost for training.
