Re: Road Relinquishment Agreement with Missouri Highways & Transportation Commission for

Conveyance of a Portion of Business Route 63

Executive Summary

Repeal Ordinance 022850 dated June 20, 2016 and authorize the City Manager to execute a new road relinquishment agreement with the Missouri Highways and Transportation Commission (MHTC) for the conveyance of a portion of Business Route 63 from Business Loop 70 southerly to Route 740/Stadium Boulevard and from Route 740/Stadium Boulevard southerly to Route AC.

Discussion

On June 20, 2016 Council Bill 142-16 was passed authorizing a road relinquishment agreement with MHTC for the conveyance of 2.275 miles of Business Route 63 from Business Loop 70 southerly to Route 740/Stadium Boulevard, and 1.150 miles from Route 740/Stadium Boulevard southerly to Route AC. The Public Works Street division has maintained this roadway for a number of years and the agreement merely transferred ownership and maintenance from the state to the City.

Staff was recently contacted by MoDOT concerning a change in route status conveying an additional 0.183 miles of Business Route 63 at the Stadium intersection; therefore, staff is requesting that Council repeal Ordinance 022850 and authorize the City Manager to execute a new road relinquishment agreement with MHTC conveying 2.341 miles of Business Route 63 from Business Loop 70 southerly to Route 740/Stadium Boulevard, and 1.267 miles from Route 740/Stadium Boulevard southerly to Route AC.
