Re: Authorizing a Long Term Lane Closure and Sidewalk Closure on Tiger Avenue between Rollins Street and Kentucky Avenue, and a Short Term Closure of Rollins Street between Missouri Avenue and Tiger Avenue

Executive Summary

Staff has prepared for Council consideration a resolution authorizing the University of Missouri to close a lane and the east sidewalk along Tiger Avenue between Rollins Street and Kentucky Avenue from May 14, 2018 until August 3, 2018. In addition, the University of Missouri is requesting a closure of Rollins Street between Missouri Avenue and Tiger Avenue from May 14, 2018. The University of Missouri is requesting these closures to allow for repair of deteriorated utilities serving their campus.

Discussion

The long term closure includes:

- The eastern most lane of Tiger Avenue between Rollins Street and Kentucky Avenue.
- The sidewalk on the east side of Tiger Avenue between Rollins Street and Kentucky Avenue.
- Rollins Street between Missouri Avenue and Tiger Avenue.

The closures along Tiger Avenue would begin May 14, 2018 and end on August 3, 2018. During this lane closure, two-way traffic will be maintained, but the sidewalk along the east side of Tiger Avenue will be closed to pedestrians.

The closure on Rollins Street between Missouri Avenue and Tiger Avenue would begin May 14, 2018 and end no later than June 1, 2018. The closure of Rollins Street will be a complete closure with westbound traffic detoured down Missouri Avenue to Conley Avenue to Tiger Avenue; and eastbound traffic detoured down Tiger Avenue to Hospital Drive to Virginia Avenue. Rollins Street shall be opened to traffic no later than 5:00 p.m. on June 1, 2018.

The University's contractor, Sircal Contracting, will be making repairs to deteriorated utilities serving their campus. Staff has reviewed the attached traffic control plans and has no issues with their request. The University of Missouri has contacted property owners affected by this closure and a list of these owners and a copy of the letter submitted is attached.

The University of Missouri and/or its contractor will be responsible for all signs and barricades necessary for the protection and convenience of the general public. The University of Missouri is exempt from any public inconvenience fee.
