SECTION 2. The authorization of the bonds by the voters will authorize the City to fix, establish, maintain and collect rates and charges for the use and services provided by the City through its Water and Electric Systems, including all extensions and improvements thereto hereafter constructed or acquired by the City, in addition to the other rates and charges for such services provided by law, as will produce income and revenues sufficient to provide funds to pay the costs of operation and maintenance of the Water and Electric

Systems and the principal of and interest on the bonds as they become due and to retire the same within thirty-five (35) years from the date thereof, and to provide for the establishment of reasonable reserves therefor.
