#### Executive Summary

At its June 4, 2018 meeting, City Council approved an appropriation of funds for Columbia Sports Fieldhouse, including an increase to the 1% for Art amount of \$13,310.

The Standing Committee on Public Art recommends that David Spear's Percent for Art Artist's Contract be amended to include additional funding as well as an updated design proposal to add additional design component(s) to the artwork.

#### Discussion

At its March 19, 2018 meeting, City Council approved the Percent for Art artist agreement with David Spear. Upon execution of the original contract, the artist began work on an initial design proposal.

At its June 4, 2018 meeting, City Council approved an appropriation of funds for Columbia Sports Fieldhouse, including an increase to the 1% for Art amount of \$13,310. The Standing Committee on Public Art met and has recommended that David Spear's Artist's Contract be amended to include the additional funding as well as an updated design proposal with additional design component(s) to the artwork.

Once the amendment to the contract is signed, Mr. Spear will have thirty (30) days to prepare and submit an amended proposal for the artistic work for the project. His final design will go through the same approval process as this artist selection has: from the Standing Committee to the Commission to the City Council.

### Fiscal Impact

Short-Term Impact: The updated total amount for the Columbia Sports Fieldhouse Percent for Art project is \$50,310. Of those funds, \$42,764 are set aside for the artist's commission. This includes construction, fabrication and installation. \$5,031 is set aside for lifetime maintenance and \$2,515 for administration. No staff salaries are paid from Percent for Art funds. Any administrative dollars left at the close of the project will revert to the maintenance fund. Long-Term Impact: None.
