Executive Summary

Volunteer Programs, part of the Community Development Department, is submitting for approval three Adopt-A-Spot Beautification agreements to allow volunteers to care for landscaping in street right of way.

Discussion

Volunteers are responsible for maintaining 101 landscaped beds in city or state right of way in the City of Columbia. Adopters are responsible for weeding, watering, and mulching the beds and planting annual flowers and bulbs. Agreements are written for a four-year commitment and each bed has a sign to acknowledge the efforts of the adopter. Currently 83 beds, or 82%, have adopters

Staff is asking for council to approve three agreements with volunteers to maintain beds:

- Columbia Honda will be taking over maintenance of Forum median bed #4 near the intersection of Canterbury Drive and Forum Boulevard.
- John Ott has asked to landscape three small beds in the alley between 10th and Orr Streets to the south of Wabash Station. Mr. Ott is currently a program participant by caring for beds on Short Street.
- Tamara Tennenbaum and Millersburg Valley Landscaping are adopting a new bed to the program located in Rolling Hills Road just south of Route WW. Ms. Tennenbaum has provided care for a bed at Forum Chapel Plaza so we are grateful for her work on a second bed. She has cooperated with staff in the Office of Sustainability and the Street Division on planting this bed.

City staff will work with these volunteers to provide mulch, annual flowers, bulbs and plants as needed to help them be successful. City staff review the beds two to three times each year to provide feedback to volunteers and help ensure program quality. Staff will terminate agreements with volunteers who are not meeting the standards for weed free beds with color throughout the growing season. The City's Volunteer Programs staff appreciates the investment that volunteers put into Adopt-A-Spot beds to be enjoyed by hundreds of residents and visitors each day.

Fiscal Impact

Short-Term Impact: The City will provide signs acknowledging the work of each adopter for a total cost of \$390. In addition the City will provide mulch, plants, annuals and bulbs for a total two year cost not to exceed \$4000.

Long-Term Impact: The City's Volunteer Programs provides ongoing support for Adopt A Spot beds including water meter and hydrant maintenance and repair, replacement plants, mulch, bulbs and annual flowers. No more than \$15,000 is spent on the program to support more than 90 beds. Volunteers provide the labor to maintain these beds at no cost to the City.
