## Executive Summary

This is the Public Hearing for the construction of public sanitary sewers to serve the properties located within the PCCE #18 Spring Valley Road Sanitary Sewer Improvement Project. The project location is shown on the attached map. The proposed sanitary sewer project will eliminate private common collector sewers in the area and serve seven (7) properties along W Broadway, Spring Valley Road and Garden Court. The cost estimate for this sewer project is \$100,000, and payment shall come from the Sewer Utility Private Common Collector Elimination Funds.

### Discussion

PCCE #18 – Spring Valley Road Sanitary Sewer Improvement Project will consist of constructing approximately 420 feet of gravity sewer main and will include new private service connections and replacement of service laterals required to reconnect the existing structures to the new sewer main. The proposed sewer will replace the existing private common collector sewers in the area. Easements will need to be donated by three (3) property owners benefiting from the project.

In October 2009, Council directed staff to conduct a preliminary feasibility study to determine the scope of work on the project. Sewer Utility staff held an Interested Parties Meeting at City Hall on April 25, 2018. Four (4) property owners attended the meeting, all in support of the project.

The resolution estimate for this project is \$100,000. Funding for this project will be from Sewer Utility funds and special assessments will not be levied in accordance with Section 22-253 of City Code.

Fiscal Impact

Short-Term Impact: Construction cost is estimated at \$100,000 and will be paid from the Sewer Utility funds.

Long-Term Impact: It is anticipated that this project will have a minimal impact on the Sewer Utility's annual operating cost.
