## AN ORDINANCE

amending Chapter 22 of the City Code as it relates to solid waste rates and services; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 22 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 22-161. Commercial service.

(b) *Commercial collection methods and rates.* The following refuse collection methods and rates shall apply to commercial customers as approved by the director:

(3) Front loading compactor boxes, per cubic yard capacity ....... \$23.17-24.51

(e) *Roll-off and compactor refuse containers.* The fees for such service shall be as follows:

- (1) Full-sized compactor style roll-off containers: Ninety-eight dollars and fiftyone cents (\$98.51) per collection plus fifty-two dollars (\$52.00) fifty-five dollars (\$55.00) per ton with a minimum (calendar) monthly charge of ninetyeight dollars and fifty-one cents (\$98.51).
- (2) Full-sized non-compacted roll-off containers: Ninety-eight dollars and fiftyone cents (\$98.51) per collection plus fifty-two dollars (\$52.00) fifty-five dollars (\$55.00) per ton with a minimum (calendar) monthly charge of ninetyeight dollars and fifty-one cents (\$98.51).

- (3) Mini-sized compactor style roll-off containers: Seventy dollars and three cents (\$70.03) per collection plus fifty-two dollars \$52.00) fifty-five dollars (\$55.00) per ton with a minimum (calendar) monthly charge of seventy dollars and three cents (\$70.03).
- (4) Mini-sized non-compacted style roll-off containers: Seventy dollars and three cents (\$70.03) per collection plus fifty-two dollars \$52.00) fifty-five dollars (\$55.00) per ton with a minimum (calendar) monthly charge of seventy dollars and three cents (\$70.03).

Sec. 22-163. Landfill and disposal areas.

(a) Rates for landfill. Landfill fees shall be determined by weight unless scales are temporarily out of commission. The current state solid waste tonnage fee will be added to all rates where applicable except the "per ton" rate, set forth in subsection (1) below, which includes that fee. Charges for use of the landfill shall be determined by weight or volume as follows:

(1)	Per ton, or any fraction thereof	. \$ <del>52.00 <u>55.00</u></del>

(6)	Compactor trucks and compactor roll-off boxes,

SECTION 2. The new rates established in this ordinance shall take effect on October 1, 2018; provided that rates for monthly charges shall be applied to utility bills beginning with the first cycle billed in October, 2018.
