Re: Amending Chapter 14 of the City Code as it Relates to All-Way Stop Intersections

### **Executive Summary**

Staff has prepared for Council consideration an ordinance amending Section 14-63 of the City Code as it relates to all-way stop intersections within the City of Columbia. As part of a thorough review of all-way stop intersections, several locations were found to be missing from the current ordinance, modified to signals and roundabouts, or streets renamed. This amendment is merely to correct the current ordinance which is used by law enforcement and the city prosecutor for ease of enforcement of violations.

#### Discussion

A thorough review of Section 14-63 of the City Code during GIS mapping of all-way stop intersections found several discrepancies. Staff is amending Section 14-63 of the City Code as follows:

#### Add to the Ordinance:

- Ash Street & Orr Street (become all-way stop as part of Wabash-Hominy Trail project)
- Nifong Boulevard & Old Millcreek Road (meets all-way warrants)
- William Street & Anthony Street (inadequate sight distance, meets all-way warrants)
- William Street & Rollins Street (inadequate sight distance, meets all-way warrants)

### Delete from the Ordinance:

- Bethel Road & Nifong Boulevard (now signalized)
- Fairview Road & Rollins Road (now a roundabout)
- Crestland Avenue & Sunset Drive (does not meet all-way stop warrants)
- Forum Boulevard & Nifong Boulevard (now signalized)
- Highridge Drive & Mills Drive (does not meet all-way stop warrants)
- Orr Street & Park Avenue (does not meet all-way stop warrants)
- St. Andrews Street & St. Christopher Street (does not meet all-way stop warrants)

### Name Change/Correction:

- Conley Avenue & Maryland Tiger Avenue (Maryland renamed Tiger)
- Kentucky Boulevard Avenue & Maryland Tiger Avenue
- Maryland Tiger Avenue & Rollins Street
- Turner Avenue & Maryland Tiger Avenue
- Greenwood Drive Avenue & Rollins Road
