## Staff/Commission Reports

Janet Godon, Parks and Rec, announced that striping has been completed for the north-south Bike Boulevard project that will connect Business Loop 70 at Parkade Boulevard to the MKT Trail off Lathrop Road. The project is still underway.

For Slide 2: The BPC recommended separate, individual goals for bike and pedestrian travel, as well as using total # of trips as a measurement.

For Slide 4: The BPC recommedended an additional section on Pedestrian Safety: Set back sidewalks
Better/More crosswalks
Connected and improved sidewalks
Bulb Outs on Curbs

Increased investments in Vision Zero Inititives.
Collaborate to create a Safe Routes to School initiative.

Change "Restrict trucks and suvs from diagonol parking on Broadway" to "Improve safety of downtown Broadway parking, i.e. change direction of parking, increase sightlines, etc."

For Slide 7, the BPC did not decide on non-motorized transportation spending goals. Paul Lovern recommended connecting spending goals to what other cities with larger mode shares have spent. He will do some research and bring back to BPC.

For Slide 8, the BPC was in general agreement on recommending the additional action to "Develop a comprehensive data collection initiative to accurately estimate Columbia residents' primary transportation modes and related transportation GHG emissions."

Lawrence will compile the BPC recommendations into a letter for the Mayor's Climate Action Task Force.

## Bicycle Friendly Community Application Discussion

Janet Godon submitted Columbia's Bike Friendly Communities (BFC) designation application this week. Columbia has not yet recieved its designation, but we did recieve direct feedback during the application process. The BFC strongly recommends that Columbia start a bike share program, as well as a Safe Routes to Schools program.
