As chair of our congregational board, I am writing this letter on behalf of Broadway Christian Church in support of the development plan for the future site of Boone County Family Resources (BCFR) at 2700 W. Ash Street. During the past few months the Church has been in contact with BCFR and architect John Simon of Simon Associates, Inc. for this plan of the future BCFR site, located across from MBS and adjacent to Church property. BCFR has included the Church and the other surrounding neighbors in announcing their process and our church hosted an informational meeting on Sept. 11, 2018. At this meeting residents from neighboring apartments joined us in a very supportive tone. BCFR answered questions and addressed the issues brought up with practical and achievable solutions.

We have reviewed other development plans for this site and envision BCFR as a good neighbor with which we can enjoy symbiotic work. Broadway Christian and BCFR have a history of cooperation for events throughout the year, such as the Cookies with Santa event for children and families served by BCFR. We expect their new proximity to facilitate further interaction and opportunities for partnership. BCFR supports about 1800 children and adults with developmental disabilities and is a valuable entity to the Columbia community. This location would provide them with more opportunities to serve and put their mission into action.
