

A TRACT OF LAND LOCATED IN THE NORTHWEST QUARTER OF SECTION 33, TOWNSHIP 48 NORTH, RANGE 13 WEST, CITY OF COLUMBIA, BOONE COUNTY, MISSOURI, BEING ALL OF LOTS 116A AND 117A OF COPPERSTONE PLAT 7 AS RECORDED IN PLAT BOOK 46, PAGE 30 OF THE BOONE COUNTY RECORDS. SAID TRACT IS MORE PARTICULARLY DESCRIBED AS

BEGINNING AT THE NORTHEAST CORNER OF LOT 116A OF SAID COPPERSTONE PLAT 7; THENCE ALONG THE EAST LINE OF SAID LOT 116A AND 117A, SOO 03'45"W, 295.31 FEET TO THE SOUTHEAST CORNER OF SAID LOT 117A; THENCE LEAVING SAID EAST LINE AND ALONG THE SOUTH LINE OF SAID LOT 117A, N86°26'25"W, 309.26 FEET TO THE SOUTHWEST CORNER OF SAID LOT 117A AND AN IRON ON THE EAST RIGHT-OF-WAY LINE OF COPPERSTONE COURT; THENCE LEAVING SAID SOUTH LINE ALONG THE WEST LINE OF SAID LOT 116A, 117A AND THE EAST RIGHT-OF-WAY LINE OF COPPERSTONE COURT, ALONG A NON-TANGENT 225.00-FOOT RADIUS CURVE TO THE RIGHT, 36.38 FEET, SAID CURVE HAVING A CHORD WHICH BEARS NO9'34'20"E, 36.34 FEET; THENCE ALONG A 275.00-FOOT RADIUS CURVE TO THE LEFT, 149.18 FEET, SAID CURVE HAVING A CHURD WHICH BEARS NO1'20'10"W, 147.36 FEET TO THE NORTHWEST CORNER OF LOT 116A AND AN IRON ON THE EAST RIGHT-OF-WAY LINE OF COPPERSTONE COURT; THENCE LEAVING SAID WEST LINE ALONG THE NORTH LINE OF 116A, N73'07'25"E, 320.17 FEET TO THE POINT OF BEGINNING AND CONTAINING 1.65 ACRES.
