Re: Authorizing construction of the Private Common Collector Elimination Sanitary Sewer Project #18 – Spring Valley Road and calling for bids through the Purchasing Division

Executive Summary

Staff has prepared for Council consideration an ordinance authorizing construction and issuing a contract for the work or a bid call through the Purchasing division for the construction of Private Common Collector Elimination Sanitary Sewer Project #18 - Spring Valley Road, as shown on the attached diagram. The interested Parties (IP) meeting was held on April 25, 2018, and a public hearing was held July 16, 2018.

Discussion

PCCE #18 – Spring Valley Road Sanitary Sewer Improvement Project will consist of constructing approximately 420 feet of gravity sewer main and will include new private service connections and replacement of service laterals required to reconnect the existing structures to the new sewer main. The proposed sewer will replace the existing private common collector sewers in the area.

Staff anticipates utilizing term and supply contracts bid through Purchasing for this project. A term and supply contract is an appropriate way to construct a project of this type. This will enable City staff to move swiftly and also provide consistency and uniformity throughout these types of projects with regards to crews and workmanship. This ordinance authorizes constructing these improvements through the City's term and supply contracts or bidding through Purchasing as necessary.

Construction plans are 90 percent complete, and all necessary easements have been obtained. Construction is expected to begin in 2019.

Fiscal Impact

Short-Term Impact: The resolution estimate for this project is \$100,000. In accordance with Section 22-253 of City code, financing for this project will be through Sewer Utility – Private Common Collector Elimination funds.

Long-Term Impact: This project will not have a significant impact to annual maintenance and operation costs.
