MEMORANDUM OF ANTENNA AGREEMENT

THIS MEMORANDUM OF ANTENNA AGREEMENT is made and entered into by and between the City of Columbia, a municipal corporation (hereinafter "City") and USCOC of Greater Missouri, LLC, a Delaware limited liability company (hereinafter "Lessee").

WITNESSETH:

WHEREAS, by the terms of a certain Antenna Agreement dated March 3, 2004 the City granted Lessee the right to lease certain ground space and agreed to grant Lessee certain easements, all being more particularly bounded and described as set forth in Exhibit "A" attached hereto and made a part hereof (the "Premises") upon the terms and conditions set forth in the Agreement; and

WHEREAS, the City and Lessee entered into a First Amendment to Antenna Agreement dated February____ 2019, collectively the Antenna Agreement and First Amendment are hereinafter referred to as the "Agreement" and

WHEREAS, the City and the Lessee desire to execute this Memorandum of Agreement to evidence said Agreement and certain of the terms therein for the purpose of placing the same of record in the Recorder of Deeds Office for Boone County, State of Missouri.

NOW THEREFORE, in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the City did grant Lessee the right to lease the Premises and obtain certain easements upon the terms and

conditions of the Agreement which is incorporated herein by specific reference, and agree as follows:

- 1. The initial term of the Agreement was five (5) years and commenced March 4, 2004. The current term of five (5) years is scheduled to expire on March 2, 2019. Lessee may extend the Agreement for three (3) additional five (5) year renewal terms may be exercised upon the terms and conditions more particularly as set forth in the Agreement.
- 2. The City also makes certain grants of easement for access and utilities, as more particularly described on the attached Exhibit A, which easements are in effect throughout the term of the Agreement as renewed or extended, subject to terms and conditions as set forth in the Agreement.
- 3. This Memorandum of Agreement is subject to all the terms and provisions of the Agreement which is incorporated herein and made part hereof by reference as if all the provisions thereof were copied in full herein. Any conflict between the provisions of the Memorandum of Agreement and Agreement will be resolved in favor of the Agreement.
