Re: Authorizing a Bid Call for the Relocation of Route H at the Columbia Regional Airport;

and appropriating funds.

Executive Summary

Authorize a bid call through the Purchasing division for the relocation of Route H at the Columbia Regional Airport and appropriate funds. Staff anticipates that the project will be constructed in the summer of 2019. An interested parties' meeting was held on November 20, 2018, and a public hearing is being held on March 4, 2019.

Discussion

Staff is requesting that Council authorize a bid call through the Purchasing division for the relocation of Route H to the northeast. This relocation will allow the extension of the primary runway 900 feet to the north and was identified and approved by the Federal Aviation Administration (FAA) in the Capital Improvement Plan.

Council authorized a professional engineering services agreement with Burns & McDonnell in February of 2017 to provide the design services for this project, and a public hearing is being held on March 4, 2019.

Staff is requesting an appropriation of \$2,940,113.00 from the Federal Contributions Account. MoDOT funds and the local share were previously appropriated into the project.

Fiscal Impact

Short-Term Impact: Total estimated construction costs for this project is \$3,266,793.00 and is being funded by FAA \$2,940,113.00 (90%), MoDOT \$163,340.00 (5%), and City TST \$163,340.00 (5%).
