Columbia Regional Airport.

Executive Summary

Authorizing the City Manager to execute an airport aid agreement with the Missouri Highways and Transportation Commission (MHTC) for a grant in the amount of \$58,057.00. This grant will be utilized for the completion of the Documented CATEX for Columbia Regional Airport. The local match required for this project is \$6,451.00.

Discussion

The Columbia Regional Airport (COU) applied for and received a Documented CATEX grant from MHTC in the amount of \$58,057.00. The grant requires a local match of \$6,451.00 for a total project budget of \$64,508.00. This grant provides funding by MHTC for the completion of the Documented CATEX which is required by the Federal Aviation Administration for the selected site for the new terminal location.

Fiscal Impact

Short-Term Impact: The total cost of the Documented CATEX is \$64,508.00 with 90% funding being provided by MHTC in the amount of \$58,057.00 and a match of 10% or \$6,451.00. Long-Term Impact: None
