Re: Authorizing the Acquisition of a Leasehold Interest of Hangar 350 at the Columbia

Regional Airport and repealing Ordinance 023806.

### **Executive Summary**

Authorize the acquisition of a leasehold interest of Hangar 350 and affixed appurtenances in order to move forward with the construction of the new terminal at the Columbia Regional Airport and repealing Ordinance 023806 which included an incorrect legal description.

#### Discussion

A public hearing was held on May 21, 2018, for the relocation of Hangar 350, and the design and construction services for an apron expansion and taxiway reconstruction project related to the future construction of a new terminal facility at the Columbia Regional Airport.

Staff is requesting the acquisition of a leasehold interest of Hangar 350 and affixed appurtenances in order to move forward with the construction of the new terminal. Columbia Jet Center (formerly Central Missouri Aviation) owns Hangar 350, and leases the property from the City of Columbia. The original lease went into effect in 1995 and goes through May 31, 2020, with three, five-year renewal options.

The original Ordinance 023806 approved on March 04, 2019, had the incorrect legal description included. Staff is requesting this ordinance be repealed and be replaced with a new ordinance correcting the legal description of the property.

#### Fiscal Impact

Short-Term Impact: If negotiations are unsuccessful, the City will have to pay an amount set through the condemnation process.

Long-Term Impact: The ordinance will allow the City to move forward with the development of the terminal upon approval of the STAMP by the FAA.
