## **Executive Summary**

Approve and authorize the City Manager to sign an engineering services agreement with Burns and McDonnell, Inc. to complete a Documented Categorical Exclusion Environmental review in regards to the proposed new terminal site located just south of the current terminal at Columbia Regional Airport.

#### Discussion

A Documented Categorical Exclusion (CATEX) checklist is required by the Federal Aviation Administration (FAA) to justify support for development of the proposed terminal, and related aprons, taxiways, access and service roads, parking lots, and associated development. The Documented CATEX will assess the potential direct and indirect effects of construction for a new terminal building and demolition of an existing hangar along with associated developments on property owned by the City of Columbia.

#### Fiscal Impact

Short-Term Impact: The total cost for engineering services is \$64,508.00 with MoDOT reimbursing the City 90% or \$58,057.00. The City's 10% local match is \$6,451.00 and will be paid from Transportation Sales Tax.
